

House Bill 4109

Sponsored by Representative MCLANE; Representatives BARRETO, DAVIS, HACK, HUFFMAN, NEARMAN, OLSON, SPRENGER, STARK, WHISNANT, WHITSETT (Presession filed.)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Requires heads of certain state agencies to identify individuals serving in agency division leadership position or in position responding directly to director or division lead of agency. Requires identified individuals to file statement of economic interest.

2 Relating to statements of economic interest; creating new provisions; and amending ORS 244.050.

3 **Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1.** ORS 244.050 is amended to read:

5 244.050. (1) On or before April 15 of each year the following persons shall file with the Oregon
6 Government Ethics Commission a verified statement of economic interest as required under this
7 chapter:

8 (a) The Governor, Secretary of State, State Treasurer, Attorney General, Commissioner of the
9 Bureau of Labor and Industries, district attorneys and members of the Legislative Assembly.

10 (b) Any judicial officer, including justices of the peace and municipal judges, except any pro tem
11 judicial officer who does not otherwise serve as a judicial officer.

12 (c) Any candidate for a public office designated in paragraph (a) or (b) of this subsection.

13 (d) The Deputy Attorney General.

14 (e) The Deputy Secretary of State.

15 (f) The Legislative Administrator, the Legislative Counsel, the Legislative Fiscal Officer, the
16 Secretary of the Senate and the Chief Clerk of the House of Representatives.

17 (g) The president and vice presidents, or their administrative equivalents, in each public uni-
18 versity listed in ORS 352.002.

19 (h) The following state officers:

20 (A) Adjutant General.

21 (B) Director of Agriculture.

22 (C) Manager of State Accident Insurance Fund Corporation.

23 (D) Water Resources Director.

24 (E) Director of Department of Environmental Quality.

25 (F) Director of Oregon Department of Administrative Services.

 2 **listed in paragraph (h) of this subsection as serving in a division leadership position, or in a**
 3 **position responding directly to the director or division lead, or their administrative equiv-**
 4 **alent. The identification required by this paragraph must be made to the Oregon Government**
 5 **Ethics Commission not later than February 1 of each year.**

6 (2) By April 15 next after the date an appointment takes effect, every appointed public official
 7 on a board or commission listed in subsection (1) of this section shall file with the Oregon Govern-
 8 ment Ethics Commission a statement of economic interest as required under ORS 244.060, 244.070
 9 and 244.090.

10 (3) By April 15 next after the filing deadline for the primary election, each candidate described
 11 in subsection (1) of this section shall file with the commission a statement of economic interest as
 12 required under ORS 244.060, 244.070 and 244.090.

13 (4) Within 30 days after the filing deadline for the general election, each candidate described in
 14 subsection (1) of this section who was not a candidate in the preceding primary election, or who
 15 was nominated for public office described in subsection (1) of this section at the preceding primary
 16 election by write-in votes, shall file with the commission a statement of economic interest as re-
 17 quired under ORS 244.060, 244.070 and 244.090.

18 (5) Subsections (1) to (4) of this section apply only to persons who are incumbent, elected or
 19 appointed public officials as of April 15 and to persons who are candidates on April 15. Subsections
 20 (1) to (4) of this section also apply to persons who do not become candidates until 30 days after the
 21 filing deadline for the statewide general election.

22 (6) If a statement required to be filed under this section has not been received by the commis-
 23 sion within five days after the date the statement is due, the commission shall notify the public of-
 24 ficial or candidate and give the public official or candidate not less than 15 days to comply with the
 25 requirements of this section. If the public official or candidate fails to comply by the date set by the
 26 commission, the commission may impose a civil penalty as provided in ORS 244.350.

27 **SECTION 2. The amendments to ORS 244.050 by section 1 of this 2016 Act apply to**
 28 **statements of economic interest required to be filed on or after the effective date of this 2016**
 29 **Act.**
