

Requested by Senator BEYER

**PROPOSED AMENDMENTS TO
SENATE BILL 1543**

1 On page 1 of the printed bill, line 2, delete “, 805.272”.

2 Delete lines 5 through 30 and delete page 2 and insert:

3 **“SECTION 1. ORS 805.274 is amended to read:**

4 “805.274. (1) After payment of the cost of production of the wine country
5 registration plates including administrative expenses relating to marketing
6 the wine country registration plates issued under ORS 805.266, the Oregon
7 Tourism Commission shall distribute the moneys received from the Depart-
8 ment of Transportation pursuant to ORS 805.272 as follows:

9 “(a) One half of the moneys shall be distributed as matching grants. The
10 commission shall develop a matching grant program and shall award grants
11 to tourism promotion agencies for tourism promotion of wine and culinary
12 tourism. The commission shall establish the maximum grant amount in the
13 applicant guidelines prepared for the matching grant program in each
14 biennium. No more than 50 percent of the total cost of a project may be paid
15 for with moneys from the program. An applicant must show a minimum
16 one-to-one match from private or public sources other than Oregon Business
17 Development Department or commission programs. The applicant must also
18 show a cash match of at least 50 percent of the amount requested under the
19 matching grant program.

20 “(b) One half of the moneys shall be distributed to tourism promotion
21 agencies for the purpose of **wine and culinary** tourism promotion. The

1 commission shall distribute the moneys in proportion to the amount of
2 acreage in each region used for wine grape production. The commission shall
3 designate a tourism promotion agency for each region. The regions shall in-
4 clude the mid-Willamette Valley region and each other major wine producing
5 region of the state as determined by the commission. **The commission shall**
6 **require, by rule, tourism promotion agencies to collaborate with the**
7 **Oregon Wine Board and relevant regional wine industry associations**
8 **designated by the commission whenever the tourism promotion agen-**
9 **cies develop expenditure plans for moneys distributed by the depart-**
10 **ment under this section.**

11 “(2) The commission annually shall submit a report **on the moneys dis-**
12 **tributed under this section** to the Legislative Assembly in the manner
13 provided in ORS 192.245 on or before October 1.

14 “(3) The commission shall adopt rules to carry out this section.

15 “(4) As used in this section:

16 “(a) ‘Mid-Willamette Valley region’ means Marion, Polk and Yamhill
17 Counties.

18 “(b) ‘Tourism promotion’ has the meaning given that term in ORS 320.300.

19 “(c) ‘Tourism promotion agency’ has the meaning given that term in ORS
20 320.300.

21 **“SECTION 2.** ORS 805.045 is amended to read:

22 **“805.045. (1) If approval is granted under ORS 283.390,** the Department
23 of Transportation may issue:

24 **“(a)** Registration plates or other evidence of registration from any regular
25 series rather than from any specially designed government series for a vehi-
26 cle owned or operated by any state department or institution [*if approval is*
27 *granted under ORS 283.390.*]; **or**

28 **“(b) Wine country registration plates for a vehicle operated by a**
29 **member of the Oregon Wine Board in discharging the board’s duties**
30 **if requested to do so by the board.**

1 “(2) The registration period for a vehicle described under this section
2 shall be the same as the regular registration period for the type of vehicle
3 registered.

4 “(3)(a) The fee for registration or renewal of a **regular series** registra-
5 tion [of] **plate for** a vehicle under **subsection (1)(a)** of this section [*shall*
6 *be*] **is** the fee established under ORS 803.420 for registration or renewal of
7 a state-owned vehicle registered under ORS 805.040.

8 “(b) **The fee for registration or renewal of a wine country registra-**
9 **tion plate for a vehicle under subsection (1)(b) of this section is the fee**
10 **established under ORS 803.420 for that type of vehicle, and not for re-**
11 **newal of a state-owned vehicle registered under ORS 805.040. Addi-**
12 **tionally, the applicant shall pay the surcharge described under ORS**
13 **805.266.**

14 “[(2)] (4) Any vehicle registered under this section and not exempted un-
15 der ORS 815.300 must meet the requirements for certification of compliance
16 with pollution control under ORS 815.310.

17 “**SECTION 3. The amendments to ORS 805.274 by section 1 of this**
18 **2016 Act apply to wine country registration plates issued on or after**
19 **the effective date of this 2016 Act.**

20 “**SECTION 4. This 2016 Act being necessary for the immediate**
21 **preservation of the public peace, health and safety, an emergency is**
22 **declared to exist, and this 2016 Act takes effect on its passage.”.**
