PROPOSED AMENDMENTS TO SENATE BILL 1537

- On page 1 of the printed bill, delete lines 13 through 15 and insert:

- In line 11, delete the period and insert "; and
- "(D) The courses of study that are approved by the school district for the
- 20 purpose of this section.".
- Delete line 25.

- In line 26, delete "(F)" and insert "(E)". 1
- In line 27, delete "(G)" and insert "(F)". 2
- In line 28, delete "(H)" and insert "(G)". 3
- In line 29, delete "(I)" and insert "(H)". 4
- In line 30, delete "(J)" and insert "(I)". 5
- Delete lines 32 through 40. 6
- On page 3, after line 10, insert: 7
- "(c) Requires a school district to add or extend existing bus routes or 8 other transportation services for post-graduate scholars. Any transportation 9 costs incurred by a school district to add or extend existing bus routes or 10 other transportation services are not considered approved transportation 11 costs for the purposes of ORS 327.013. Nothing in this paragraph prohibits 12 post-graduate scholars from using existing bus routes or transportation ser-13
- vices provided by the school district.". 14 After line 13, insert:

- "(9) A school district may receive or expend moneys distributed from the 16 State School Fund under ORS 327.013 for post-graduate scholars who enroll 17 in courses at a community college only if the post-graduate scholars are en-18 rolled in the courses as part of a program established under this section.". 19
- Delete lines 16 through 21 and insert: 20
 - "SECTION 4. Notwithstanding section 2 (5)(a) of this 2016 Act, the weighted average daily membership assigned for each post-graduate scholar shall be adjusted as follows:
- "(1) For the 2016-2017 school year, no subtraction shall be made. 24
- "(2) For the 2017-2018 school year, by subtracting 0.15.". 25

 a program established under section 2 of this 2016 Act.
- "(d) The appropriate amount, if any, to be calculated for each postgraduate scholar participating in a program established under section 2 of this 2016 Act for purposes of calculating weighted average daily membership for State School Fund distributions under ORS 327.013.
- "(e) Consideration of appropriate funding sources that are separate from the State School Fund for post-graduate scholar programs. The consideration must include:
- "(A) Methods by which funds would be distributed to school districts;
- "(B) The stability and sustainability of funding sources that would be used to support at-risk students who are not eligible for the Oregon Promise program established under ORS 341.522 because of failure to earn the minimum cumulative grade point average; and
- "(C) The estimated cost required to establish and administer alternative funding sources.
- "(3) Provide a report to each school district that established a program under section 2 of this 2016 Act. The report shall include the following information for the 2016-2017 and 2017-2018 school years:
- "(a) The number of post-graduate scholars enrolled at the school district who participated in the program;
- 28 "(b) The number of post-graduate scholars enrolled at the school district 29 who completed a full year in the program; and
- 30 "(c) The percentage of post-graduate scholars enrolled at the school dis-

- 1 trict who participated in the program and enrolled in a second school year
- 2 at a post-secondary institution of education after completing the program.
- "SECTION 6. Section 5 of this 2016 Act is repealed on December 31, 2018.".
- On page 4, line 1, delete "6" and insert "7".
- 6 After line 6, insert:
- "SECTION 8. Section 2 of this 2016 Act is repealed on June 30,
- 8 **2021.**".
- 9 In line 7, delete "7" and insert "9".
