**PROPOSED AMENDMENTS TO  
HOUSE BILL 4060**

- 1 On page 1 of the printed bill, line 10, delete “sativa”.
- 2 Delete lines 18 through 21 and insert:
- 3 “(2) ‘Crop’ means industrial hemp grown under a single registration.”
- 4 In line 26, delete “sativa”.
- 5 On page 2, line 1, delete “sativa”.
- 6 In line 6, delete “sativa”.
- 7 On page 3, line 8, delete “sativa”.
- 8 In line 10, delete “sativa”.
- 9 In line 17, delete “the date on” and insert “January 1.”
- 10 Delete line 18.
- 11 In line 19, before “grower,” insert “A”.
- 12 On page 4, line 9, delete “9” and insert “9a”.
- 13 In line 14, before “Industrial” insert “(1)”.
- 14 After line 15, insert:
- 15 “(2) For purposes of ORS chapter 616, the department may not consider
- 16 industrial hemp or industrial hemp commodities or products to be an
- 17 adulterant.”
- 18 Delete lines 22 through 25 and insert:
- 19 **“SECTION 6. A grower shall provide the State Department of Ag-**
- 20 **riculture, in a time, form and manner prescribed by the department,**
- 21 **with an accurate description and global positioning system coordinates**

1 **of the property on which the grower’s crop is or will be located.”.**

2 On page 5, line 11, before “produced” insert “and industrial hemp com-  
3 modities and products”.

4 In line 15, delete “(1)” and insert “(2)”.

5 After line 22, insert:

6 **“SECTION 9a. (1) The State Department of Agriculture may enter**  
7 **into an agreement with the Oregon Health Authority for the purpose**  
8 **of developing standards for investigating and testing an industrial**  
9 **hemp crop to ensure that the crop contains an average**  
10 **tetrahydrocannabinol concentration that does not exceed 0.3 percent**  
11 **on a dry weight basis.**

12 **“(2) In accordance with standards developed under subsection (1)**  
13 **of this section, a laboratory licensed by the Oregon Liquor Control**  
14 **Commission under ORS 475B.560 and accredited by the authority pur-**  
15 **suant to ORS 475B.565 may test an industrial hemp crop for the pur-**  
16 **pose of determining the average tetrahydrocannabinol concentration**  
17 **of the crop.**

18 **“(3) A laboratory described in subsection (2) of this section must**  
19 **provide the test results to the department in a form and manner pre-**  
20 **scribed by the department.”.**
