 to employ any employee 19 years of age or older at wages computed

- "(3)(a) If the employer is located within a nonurban county as described in section 2 of this 2016 Act, except as provided by ORS 652.020 and the rules of the commissioner issued under ORS 653.030 and 653.261, for each hour of work time that the employee is gainfully employed, no employer shall employ or agree to employ any employee 19 years of age or older at wages computed at a rate lower than:
 - "(A) From July 1, 2016, to June 30, 2017, \$9.50.

- 2 "(C) From July 1, 2018, to June 30, 2019, \$10.50.

- "(b) After June 30, 2023, an employer described in this subsection shall pay an employee 19 years of age or older no less than \$1 per hour less than the minimum wage determined under subsection (1)(j) of this section.
- 11 "(4) The commissioner shall adopt rules for determining an 12 employer's location under subsection (2) of this section.
 - "[(2)(a)] (5)(a) The Oregon minimum wage for employees 19 years of age or older shall be adjusted [annually] for inflation[,] as provided in paragraph (b) of this subsection.
- "(b) No later than [September] April 30 of each year, beginning in [cal-16 endar year 2003 2023, the commissioner shall calculate an adjustment of the 17 wage amount specified in subsection (1)(j) of this section based upon the 18 increase, if any, [(if any)] from [August] March of the preceding year to 19 [August] March of the year in which the calculation is made in the 20 U.S. City Average Consumer Price Index for All Urban Consumers for All 21 Items as prepared by the Bureau of Labor Statistics of the United States 22 Department of Labor or its successor. 23
- "(c) The wage amount [established] as adjusted under this subsection shall[:]
- "[(A)] be rounded to the nearest five cents[; and].
- "[(B)] (d) The wage amount as adjusted under this subsection [become] becomes effective as the new Oregon minimum wage amount, replacing the [dollar figure specified in subsection (1)] minimum wage
 amount specified in subsection (1)(j) of this section, on [January 1 of the

- 6 employee under 19 years of age at wages computed at a rate lower

- 8 "(A) From July 1, 2016, to June 30, 2017, \$9.25.
- 9 "(B) After June 30, 2017, a rate adjusted annually for inflation as 10 described in paragraph (b) of this subsection.
- "(b) No later than April 30 of each year, beginning in 2017, the 11 commissioner shall calculate an adjustment of the wage amount 12 specified in paragraph (a)(A) of this subsection based upon the in-13 crease, if any, from March of the preceding year to March of the year 14 in which the calculation is made in the U.S. City Average Consumer 15 Price Index for All Urban Consumers for All Items as prepared by the 16 Bureau of Labor Statistics of the United States Department of Labor 17 or its successor. 18
- "(c) The wage amount as adjusted under this subsection shall be rounded to the nearest five cents.
- "(d) The wage amount as adjusted under this subsection becomes effective as the new Oregon minimum wage amount for employees under 19 years of age, replacing the minimum wage amount specified in paragraph (a)(A) of this section, on July 1 of the year in which the calculation is made.
