SENATE BILL 1598**

1 On page 1 of the printed bill, line 2, after “ORS” insert “475B.050,”.

2 In line 3, after “475B.500;” insert “repealing sections 16, 17 and 18, chap-
3 ter ___, Oregon Laws 2016 (Enrolled House Bill 4014);”.

4 On page 4, after line 7, insert:

8 **“SECTION 8. (1) Sections 10 and 11 of this 2016 Act are added to
9 made a part of ORS 475B.010 to 475B.395.**

10 **“(2) Section 12 of this 2016 Act is added to and made a part of ORS
11 475B.550 to 475B.590.**

12 **“SECTION 9. ORS 475B.050 is amended to read:**

13 **“475B.050. For the purpose of requesting a state or nationwide criminal
14 records check under ORS 181A.195, the Oregon Liquor Control Commission
15 may require the fingerprints of any individual listed on an application sub-
16 mitted under ORS 475B.040. **If the applicant is a legal entity, the powers
17 conferred on the commission under this section include the power to
18 require the fingerprints of:****

19 **“(1) If the applicant is a limited partnership, each partner of the
20 limited partnership;**

21 **“(2) If the applicant is a limited liability company, each member of**

1 the limited liability company;

2 “(3) If the applicant is a corporation, each director and officer of
3 the corporation;

4 “(4) Any individual who holds a financial interest of 10 percent or
5 more in the legal entity applying for the license; and

6 “(5) Any individual who is a partner, member, director or officer
7 of a legal entity with a financial interest in the legal entity applying
8 for the license.

9 **“SECTION 10.** For the purpose of requesting a state or nationwide
10 criminal records check under ORS 181A.195, the Oregon Liquor Control
11 Commission may require the fingerprints of any individual listed on
12 an application submitted under ORS 475B.218.

13 **“SECTION 11.** For the purpose of requesting a state or nationwide
14 criminal records check under ORS 181A.195, the Oregon Liquor Control
15 Commission may require the fingerprints of any individual listed on
16 an application submitted under ORS 475B.235. If the applicant is a
17 legal entity, the powers conferred on the commission under this sec-
18 tion include the power to require the fingerprints of:

19 “(1) If the applicant is a limited partnership, each partner of the
20 limited partnership;

21 “(2) If the applicant is a limited liability company, each member of
22 the limited liability company;

23 “(3) If the applicant is a corporation, each director and officer of
24 the corporation;

25 “(4) Any individual who holds a financial interest of 10 percent or
26 more in the legal entity applying for the certificate; and

27 “(5) Any individual who is a partner, member, director or officer
28 of a legal entity with a financial interest in the legal entity applying
29 for the certificate.

30 **“SECTION 12.** For the purpose of requesting a state or nationwide

1 **criminal records check under ORS 181A.195, the Oregon Liquor Control**
2 **Commission may require the fingerprints of any individual listed on**
3 **an application submitted under ORS 475B.560. If the applicant is a**
4 **legal entity, the powers conferred on the commission under this sec-**
5 **tion include the power to require the fingerprints of:**

6 **“(1) If the applicant is a limited partnership, each partner of the**
7 **limited partnership;**

8 **“(2) If the applicant is a limited liability company, each member of**
9 **the limited liability company;**

10 **“(3) If the applicant is a corporation, each director and officer of**
11 **the corporation;**

12 **“(4) Any individual who holds a financial interest of 10 percent or**
13 **more in the legal entity applying for the license; and**

14 **“(5) Any individual who is a partner, member, director or officer**
15 **of a legal entity with a financial interest in the legal entity applying**
16 **for the license.**

17 **“SECTION 13. If House Bill 4014 becomes law, sections 16, 17 and**
18 **18, chapter __, Oregon Laws 2016 (Enrolled House Bill 4014), are re-**
19 **pealed.”.**

21 In line 17, delete “9” and insert “15”.
