19 **ing ORS 475B.400 to 475B.525.**

20 **“(2) The authority shall deposit moneys collected under ORS**  
21 **475B.420 in the Oregon Health Authority Fund established under ORS**

1 413.101. Moneys deposited in the fund under this subsection are con-  
2 tinuously appropriated to the authority for administering and enforc-  
3 ing ORS 475B.400 to 475B.525.

4 **“SECTION 11. (1) Fees adopted by the Oregon Health Authority**  
5 **under ORS 475B.435 may not exceed, together with other fees adopted**  
6 **under ORS 475B.400 to 475B.525, the cost of administering and enforc-**  
7 **ing ORS 475B.400 to 475B.525.**

8 **“(2) The authority shall deposit moneys collected under ORS**  
9 **475B.435 in the Oregon Health Authority Fund established under ORS**  
10 **413.101. Moneys deposited in the fund under this subsection are con-**  
11 **tinuously appropriated to the authority for administering and enforc-**  
12 **ing ORS 475B.400 to 475B.525.**

13 **“SECTION 12. (1) Fees adopted by the Oregon Health Authority**  
14 **under ORS 475B.450 may not exceed, together with other fees adopted**  
15 **under ORS 475B.400 to 475B.525, the cost of administering and enforc-**  
16 **ing ORS 475B.400 to 475B.525.**

17 **“(2) The authority shall deposit moneys collected under ORS**  
18 **475B.450 in the Oregon Health Authority Fund established under ORS**  
19 **413.101. Moneys deposited in the fund under this subsection are con-**  
20 **tinuously appropriated to the authority for administering and enforc-**  
21 **ing ORS 475B.400 to 475B.525.**

22 **“SECTION 13. (1) Sections 9 (1), 10 (1), 11 (1) and 12 (1) of this 2016**  
23 **Act apply to fees adopted on and after July 1, 2017.**

24 **“(2) Sections 9 (2), 10 (2), 11 (2) and 12 (2) of this 2016 Act apply to**  
25 **fee moneys collected on and after July 1, 2017.”.**

26 In line 11, delete “8” and insert “14”.

27 In line 17, delete “9” and insert “15”.
