**PROPOSED AMENDMENTS TO
HOUSE BILL 4073**

1 On page 1 of the printed bill, delete line 3 and insert “106.130, 106.150 and
2 659A.403.”.

3 After line 24, insert:

4 “(4)(a) A judicial officer, county clerk, religious congregation or organ-
5 ization, clergyperson, secular organization or celebrant or officiant of any
6 secular organization authorized to solemnize marriages under subsection (2)
7 of this section:

8 “(A) Is not required to solemnize a marriage; and

9 “(B) Is immune from any liability, civil or criminal, for the declination
10 or refusal to solemnize a marriage.

11 “(b) A declination or refusal to solemnize a marriage made by a person
12 or entity authorized to solemnize marriages under this subsection for the
13 reason that the person or entity disagrees with the marriage on moral, reli-
14 gious or other grounds may not be considered discrimination in a place of
15 public accommodation under ORS 659A.403.”.

16 In line 25, delete “(4)(a)” and insert “(5)(a)”.

17 On page 2, line 7, delete “(5)” and insert “(6)” and delete “(4)” and insert
18 “(5)”.

19 In line 12, delete “(6)” and insert “(7)”.

20 In line 13, delete “(5)” and insert “(6)”.

21 In line 15, delete “(7)” and insert “(8)”.

1 In line 16, delete “(5)” and insert “(6)”.

2 In line 22, delete “(8)” and insert “(9)”.

3 In line 25, delete “(9)” and insert “(10)”.

4 In line 26, delete “(4)(a)” and insert “(5)(a)”.

5 In line 27, delete “(4)(d)” and insert “(5)(d)”.

6 On page 3, after line 32, insert:

7 **“SECTION 5.** ORS 659A.403 is amended to read:

8 “659A.403. (1) Except as provided in subsection (2) of this section, all
9 persons within the jurisdiction of this state are entitled to the full and equal
10 accommodations, advantages, facilities and privileges of any place of public
11 accommodation, without any distinction, discrimination or restriction on
12 account of race, color, religion, sex, sexual orientation, national origin,
13 marital status or age if the individual is of age, as described in this section,
14 or older.

15 “(2) Subsection (1) of this section does not prohibit:

16 “(a) The enforcement of laws governing the consumption of alcoholic
17 beverages by minors and the frequenting by minors of places of public ac-
18 commodation where alcoholic beverages are served;

19 “(b) The enforcement of laws governing the use of marijuana items, as
20 defined in ORS 475B.015, by persons under 21 years of age and the frequen-
21 ting by persons under 21 years of age of places of public accommodation
22 where marijuana items are sold; [or]

23 “(c) The offering of special rates or services to persons 50 years of age
24 or older; **or**

25 **“(d) The declination or refusal to solemnize a marriage by a person
26 or entity authorized to solemnize marriages under ORS 106.120.**

27 “(3) It is an unlawful practice for any person to deny full and equal ac-
28 commodations, advantages, facilities and privileges of any place of public
29 accommodation in violation of this section.”.

30 In line 33, delete “5” and insert “6” and delete “and 106.150” and insert

1 “; 106.150 and 659A.403”.

2 In line 34, delete “4” and insert “5”.
