- **"SECTION 3.** ORS 742.585 is amended to read:
- 5 "742.585. As used in ORS 742.585 to 742.600:
- "(1) 'Active driver' means an individual who makes the individual's
- vehicle available for a period of time to await a request to transport
- 8 a customer of a transportation network company, who is en route to
- 9 transport a customer of the transportation network company or who
- is transporting a customer of the transportation network company to
- 11 the customer's requested destination.
- 12 "(2) 'Company insurance policy' means a motor vehicle liability in-
- 13 surance policy that a transportation network company obtains and
- 14 **that:**

- 15 "(a) Includes all coverage necessary to comply with the financial
- or future responsibility requirements of ORS chapter 806;
- 17 "(b) Includes the personal injury protection coverage required under
- 18 **ORS 742.518 to 742.542:**
- 19 "(c) Includes the uninsured motorist coverage required under ORS
- 20 **742.500 to 742.506**;
 - "(d) Includes comprehensive property damage coverage for the ve-

- "(e) Includes collision property damage coverage for the vehicle; and
- "(f) Does not include any other optional coverage that the owner of the vehicle selects and includes in the owner's insurance policy.
- 6 "[(1)] (3) 'Owner's insurance policy' means a private passenger motor vehicle liability insurance policy that includes:
- 8 "(a) All coverage necessary to comply with the financial or future re-9 sponsibility requirements of ORS chapter 806;
- "(b) The personal injury protection coverage required under ORS 742.518 to 742.542;
- "(c) The uninsured motorist coverage required under ORS 742.500 to 742.506; and
- "(d) Any optional coverage selected by the owner.
- "[(2)] (4) 'Personal vehicle sharing' means the use of a private passenger motor vehicle by persons other than the vehicle's registered owner in connection with a personal vehicle sharing program.
 - "[(3)] (5) 'Personal vehicle sharing program' means a legal entity **that is** qualified to do business in this state **and that is** engaged in the business of facilitating the sharing of private passenger motor vehicles for noncommercial use by individuals within this state.
- "[(4)] (6) 'Private passenger motor vehicle' means a four-wheel passenger or station wagon type motor vehicle insured under a motor vehicle liability insurance policy [covering] that covers a single individual or individuals [residing] who reside in the same household as the named insured.
- "[(5)] (7) 'Program insurance policy' means a motor vehicle liability insurance policy that [is obtained by] the personal vehicle sharing program obtains and that:
- "(a) Includes all coverage needed to comply with the financial or future responsibility requirements of ORS chapter 806;

- "(b) Includes the personal injury protection coverage required under ORS 742.518 to 742.542;
- 3 "(c) Includes the uninsured motorist coverage required under ORS 742.500 4 to 742.506;
- 5 "(d) Includes comprehensive property damage coverage for the vehicle;
- 6 "(e) Includes collision property damage coverage for the vehicle; and
- "(f) Does not include any other optional coverage [selected by] that the owner of the vehicle selects and [included] includes in the owner's insurance policy.
 - "(8)(a) 'Transportation network company' means a legal entity that is qualified to do business in this state and that is engaged in the business of providing for-hire transportation by means of mobile application software through which passengers may request transportation from drivers who control or operate private passenger motor vehicles to provide the transportation that passengers request.
 - "(b) 'Transportation network company' does not include a legal entity that is qualified to do business in this state and:
 - "(A) That is engaged in the business of providing transportation along fixed routes or at regular intervals; or
- "(B) That is engaged in the business of providing for-hire transportation using motor vehicles that the entity owns, operates or otherwise controls.
 - "SECTION 4. Section 5 of this 2016 Act is added to and made a part of ORS 742.585 to 742.600.
 - "SECTION 5. (1) A transportation network company shall purchase a company insurance policy that covers each private passenger motor vehicle that the vehicle's registered owner or designated operator uses while participating as an active driver with the transportation network company in a coverage amount that is not less than \$1 million. The limits for any coverage included in the company insurance policy that

is also included in the owner's insurance policy must be equal to or greater than the coverage limits provided in the owner's insurance policy. The transportation network company shall require the vehicle owner to report the vehicle owner's motor vehicle liability insurance coverage to the transportation network company before engaging the vehicle owner as an active driver with the transportation network company. The transportation network company may not provide mo-tor vehicle liability coverage that is less than three times the limits specified in ORS 806.070.

"(2)(a) Before engaging an individual as an active driver, a transportation network company shall require the individual to submit an affidavit to the transportation network company and to the individual's insurer that states that the individual is using the individual's motor vehicle as an active driver with a transportation network company. The transportation network company shall require and maintain as part of the transportation network company's records for the individual a copy of the affidavit and proof that the individual submitted the affidavit to the individual's insurer.

"(b) If a local jurisdiction requires an individual to obtain a permit to serve as an active driver with a network transportation company, the local jurisdiction shall require as part of the process of obtaining the permit that the individual submit an affidavit to the local jurisdiction and to the individual's insurer that states that the individual is using the individual's motor vehicle as an active driver with a transportation network company. The local jurisdiction shall require and maintain as part of the local jurisdiction's records for the individual a copy of the affidavit and proof that the individual submitted the affidavit to the individual's insurer.

"SECTION 6. ORS 742.595 is amended to read:

"742.595. (1) Notwithstanding any provision in the owner's insurance pol-

- 1 icy and notwithstanding ORS chapters 742, 806, 822 and 825 and ORS 30.010
- 2 to 30.100, 30.135, 30.480 and 30.485, in the event of any loss or injury that
- 3 occurs at any time when [the vehicle is under the operation and control of] a
- 4 person[,] other than the vehicle's registered owner[, pursuant to] operates
- or controls the vehicle while participating in a personal vehicle sharing
- 6 program, [or] when the vehicle is otherwise under the control of a personal
- 7 vehicle sharing program[,] or when the vehicle owner or a designated
- 8 operator controls or operates the vehicle while participating as an ac-
- 9 tive driver with a transportation network company, the program or
- company shall assume all liability of the vehicle owner and [shall be con-
- sidered] is the vehicle owner for all purposes.
- "(2) [Nothing in] Subsection (1) of this section **does not limit**:
- "(a) [Limits] The liability of a personal vehicle sharing program or
- 14 **transportation network company** for any acts or omissions by the program
- or company that result in injury to any persons as a result of the use or
- operation of the program or company; or
- "(b) [Limits] The ability of the personal vehicle sharing program or
- 18 transportation network company to, by contract, seek indemnification
- 19 from the vehicle's registered owner for any claims [paid by] the personal
- 20 vehicle sharing program or transportation network company pays for any
- 21 loss or injury resulting from the vehicle owner's fraud or material misrep-
- resentation in [the maintenance of] maintaining the vehicle [by the vehicle's
- 23 registered owner].
- 24 "(3) A personal vehicle sharing program [continues to be] is liable under
- subsection (1) of this section until:
- 26 "(a) The vehicle is returned to a location [designated by] that the pro-
- 27 gram **designates**; and
- 28 "(b)(A) The expiration of the time period established for the vehicle oc-
- 29 curs;
- "(B) The intent to terminate the vehicle's personal vehicle sharing use is

1 verifiably communicated to the program; or

- "(C) The vehicle's registered owner takes possession and control of the vehicle.
- "(4) A transportation network company is liable under subsection
 (1) of this section for as long as the vehicle owner or designated operator participates as an active driver with the transportation network
 company.
 - "[(4)(a)] (5)(a) A personal vehicle sharing program or transportation network company shall assume liability for a claim in which a dispute exists as to who [was in control of] controlled a private passenger motor vehicle when the loss [giving] that gave rise to the claim occurred.
 - "(b) The insurer of the vehicle shall indemnify the **personal vehicle** sharing program or transportation network company to the extent of the insurer's obligation under the owner's insurance policy, if [it is determined that] the vehicle's registered owner [was in control of] controlled the vehicle at the time of the loss.
 - "[(5)] (6) If a private passenger motor vehicle's registered owner is named as a defendant in a civil action for any loss or injury that occurs at any time when [the vehicle is under the operation and control of] a person[,] other than the vehicle's registered owner[, pursuant to] controls or operates the vehicle while participating in a personal vehicle sharing program, [or] at a time when the vehicle is otherwise under the control of a personal vehicle sharing program[,] or at a time when the vehicle's registered owner or a designated operator controls or operates the vehicle while participating as an active driver with a transportation network company, the program [shall have] or company has the duty to defend and indemnify the vehicle's registered owner.
 - "[(6)] (7) Notwithstanding any provision in the owner's insurance policy, while [the vehicle is under the operation and control of] a person[,] other than the vehicle's registered owner[, pursuant to] controls or operates the ve-

- hicle while participating in a personal vehicle sharing program, [or] the 1 **vehicle** is otherwise under the control of a personal vehicle sharing program 2 or the vehicle's registered owner or a designated operator controls or 3 operates the vehicle while participating as an active driver with a 4 transportation network company:
- "(a) The insurer of the vehicle on file with the Department of Transpor-6 tation may exclude any and all coverage afforded under the insurer's policy; 7 and 8
 - "(b) A primary or excess insurer of the owners, operators or maintainers of the vehicle may notify an insured that the insurer [has no] does not have a duty to defend or indemnify any person or organization for liability for any loss that occurs [during use of the vehicle pursuant to] when a person other than the vehicle's registered owner controls or operates the vehicle while participating in a personal vehicle sharing program, the vehicle is otherwise under the control of a personal vehicle sharing program or the vehicle's registered owner or a designated operator controls or operates the vehicle while participating as an active driver with a transportation network company.
 - "[(7)] (8) An owner's insurance policy for a private passenger motor vehicle may not be canceled, voided, terminated, rescinded or nonrenewed solely on the basis that the vehicle has been made available for personal vehicle sharing pursuant to a personal vehicle sharing program or that the vehicle's registered owner has made the vehicle available for the vehicle owner or a designated operator to use to participate as an active driver with a transportation network company that is in compliance with the provisions of ORS 742.585 to 742.600.
 - "SECTION 7. The amendments to ORS 742.585 and 742.595 by sections 3 and 6 of this 2016 Act apply to policies entered into, renewed or modified on or after the effective date of this 2016 Act.".
