**PROPOSED AMENDMENTS TO  
A-ENGROSSED SENATE BILL 1517**

1 On page 1 of the printed A-engrossed bill, line 10, delete “for” and insert  
2 “that applies” and delete “of” and insert “for”.

3 On page 2, line 9, delete “215.213 (1)(o)” and insert “215.283 (1)(m)”.

4 In line 10, delete “shall” and insert “may” and delete “establishing” and  
5 insert “reviewing”.

6 In line 20, after “a” insert “project-specific”.

7 Delete line 23 and insert:

8 “(b) Any person whose use of the person’s property may be adversely af-  
9 fected by the proposed use;”.

10 In line 26, after “submitted” insert “or that has expertise related to issues  
11 raised by the application or by comments received by the governing body”.

12 Delete lines 27 through 29 and insert:

13 “(e) For the purpose of assisting in the project-specific collaborative pro-  
14 cess, any person with technical expertise in:

15 “(A) Creating, restoring or enhancing wetlands in Tillamook County;

16 “(B) Creating, restoring or enhancing wetlands in areas with site char-  
17 acteristics similar to those identified in the application for the use; or

18 “(C) The impacts of wetlands on agricultural operations.”.

19 In line 30, after “a” insert “project-specific”.

20 In line 34, after “a” insert “project-specific”.

21 After line 37, insert:

1 “(6) The governing body shall discontinue a project-specific collaborative  
2 process requested under subsection (3) of this section if, at any time during  
3 the process, the applicant requests that the governing body resume process-  
4 ing the permit application under the procedures required by ORS 215.402 to  
5 215.438.”.

6 In line 38, delete “the pilot program required” and insert “a pilot program  
7 authorized”.

8 In line 39, delete “may” and insert “shall, subject to subsection (4) of this  
9 section,”.

10 Delete lines 44 and 45.

11 On page 3, delete line 1.

12 In line 2, delete “(3)” and insert “(2)” and delete “of Tillamook County”  
13 and delete “impacted”.

14 In line 5, delete “(4)” and insert “(3)”.

15 In line 12, delete “environmental”.

16 In line 15, delete “environmental”.

17 In line 23, delete “environmental”.

18 After line 24, insert:

19 “(4) The governing body is not required to initiate the planning process  
20 provided for in this section if the governing body determines that adequate  
21 funding, which may include funding from any combination of local, state,  
22 federal or other sources, is not reasonably available.

23 “(5) If a plan developed under this section is acknowledged pursuant to  
24 ORS 197.625, the governing body may, by ordinance, adopt a process for de-  
25 nying permits or streamlining the permitting process for permit applications  
26 subject to the pilot program under section 4 of this 2016 Act. Ordinances  
27 adopted under this section must provide for a process that is consistent with  
28 the priorities identified in the plan.”.

29 In line 25, delete “or” and insert “and”.

30 In line 30, after “wetlands” insert “are”.

1 In line 34, after “commenced” insert “, or required permits had been is-  
2 sued,”.

3 In line 36, delete “project” and insert “of the wetlands”.

4 In line 39, delete “the pilot program” and insert “a pilot program adopted  
5 under section 4 of this 2016 Act”.

6 After line 42, insert:

7 “(2) In developing a report required by this section, the governing body  
8 must consult with stakeholders including, but not limited to, representatives  
9 of conservation interests and agricultural interests, state and federal agen-  
10 cies and Indian tribes.”.

11 In line 43, delete “(2)” and insert “(3)”.

12 On page 4, delete lines 1 through 4 and insert:

13 “(b) The number of permit applications received under the pilot program  
14 adopted under section 4 of this 2016 Act, the number of applicants that have  
15 requested entering into a project-specific collaborative process to settle dis-  
16 putes concerning their applications and the disposition of applications re-  
17 ceived under the pilot program; and”.

18 In line 7, delete “(3)” and insert “(4)”.

19 In line 10, delete “June 30, 2026” and insert “January 2, 2027”.
