**LC 020** - Changes the start date of odd-numbered year regular sessions to the Tuesday after the Martin Luther King, Jr. holiday. Continues current start date in even-numbered year regular sessions. Takes effect 91 days after sine die.

**LC 202** - Relating to public safety. Directs the Department of Justice to adopt rules governing the Batterer's Intervention Program (BIP) that are applicable to all genders, evidence-based and designed to reduce recidivism. Requires the BIP advisory committee to include a psychologist or psychiatrist who has experience working with BIPs.

Conforms ORS 147.397 to Melissa's Law (2016 SB 1571), by utilizing consistent terminology and by requiring law enforcement agencies to retain sexual assault forensic evidence kits for 60 years. Directs the Department of Justice to create informational materials describing the medical expenses that may be paid by the Sexual Assault Victims' Emergency Medical Response Fund. Requires providers of sexual assault medical assessments to make the materials available to victims of sexual assault.

Directs the state hospital and other health care providers to provide the Psychiatric Security Review Board with medical records pertaining to persons placed under the jurisdiction of the Board. Modifies the authority to revoke conditional release of persons under jurisdiction of the Board.

Modifies the criminal penalties applicable to flying a drone that is capable of causing serious physical injury. Expands the class of educational institutions exempt from the obligation to notify a licensing agency of the intention to use a drone capable of firing a projectile in an area open to the public.

**LC 203** - Allows a marijuana processor to receive and process marijuana for medical purposes into cannabinoid products, cannabinoid concentrates, and cannabinoid extract for a person designated to produce marijuana by a registry identification cardholder. Eliminates certain testing requirements for these cannabinoid products, cannabinoid concentrates, and cannabinoid extracts when the processor receives marijuana from, and processes for, a registry identification cardholder or designated primary caregiver of a registry identification cardholder.

Removes 24 or more inches in height specification for immature plants. Removes current immature plant limit. Leaves number of allowable immature plants, regardless of height, to be determined.
