



Notes on crime data (UNDOC)

Definitions:

Assault "Serious Assault" means the intentional or reckless application of serious physical force inflicted upon the body of a person resulting in serious bodily injury. Serious physical force, at minimum, includes being shot, stabbed, cut, hit by an object or poisoned. "Serious Assault" should exclude the application of minor physical force (such as hitting, slapping or pushing), resulting in no injury or minor bodily injury. "Sexual assault", "Threat" and "Assault leading to death" should also be excluded.

Burglary "Burglary" means gaining unauthorized access to a part of a building/dwelling or other premises with or without the use of force against the building/dwelling, with intent to commit theft or when actually committing theft. "Burglary" should include, breaking and entering business premises (office buildings, shops, clubs, banks factories, hotels etc); residential premises (house, apartment or other dwelling place that is the habitual place of residence of the victim); or public premises owned, rented or leased by public bodies. "Burglary" should exclude theft from a car, container, vending machine, parking meter and from a fenced meadow/compound.

Domestic burglary "Domestic burglary/burglary of private residential premises" means burglary of real estate owned, rented, or leased by a person, including a house, apartment or other dwelling place.

Homicide "Intentional Homicide" means unlawful death purposefully inflicted on a person by another person. Data on intentional homicide should also include serious assault leading to death and death as a result of a terrorist attack. It should exclude attempted homicide, manslaughter, death due to legal intervention, justifiable homicide in self-defense and death due to armed conflict.

Motor Vehicle Theft "Theft of a Motorized Land Vehicle" means the theft of a motorized land vehicle. 'Motorized land vehicle' means all land vehicles with an engine that run on the road, including cars, motorcycles, buses, lorries, construction and agricultural vehicles. "Theft of a motorized land vehicle" should exclude the illegal use of a motorized land vehicle with intent to temporarily deprive it from the owner ('joyriding').

Rape "Rape" means sexual penetration without valid consent or with consent as a result of intimidation, force, fraud, coercion, threat, deception, use of drugs or alcohol, abuse of power or of a position of vulnerability, or the giving or receiving of benefits.

Robbery "Robbery" means unlawfully taking or obtaining property with the use of force or threat of force against a person with intent to permanently or temporarily withhold it from a person or organization. "Robbery" should include theft with violence from the person (mugging, bag-snatching with force), robbery of valuables or goods in transit, of an establishment or institution, of livestock and other acts of robbery involving the use of force against a person. "Robbery" should exclude theft without violence (pick pocketing), "Burglary" and extortion.

Theft "Theft" means unlawfully taking or obtaining of property with the intent to permanently withhold it from a person or organization without consent and without the use of force, threat of force or violence, coercion or deception. "Theft" excludes "Burglary", "Robbery", and "Theft of a Motorized Land Vehicle", which are recorded separately.

General:

Data supplied by countries may not exactly reflect the definition provided by UNODC.

Data interpretation: When using the figures, any cross-national comparison should be conducted with caution because of the differences that exist between the legal definitions of offences in countries, the different methods of offence counting and recording and differences in the share of criminal offences that are not reported to or detected by law enforcement authorities (i.e. the dark figure).
