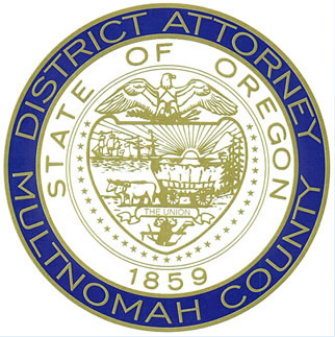

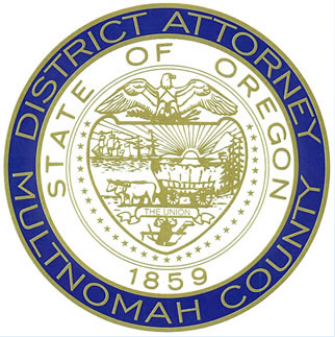

TREATMENT FIRST PROGRAM

1. MISSION & PURPOSE

Since 1991, the Multnomah County Sanctions Treatment Opportunities Progress (STOP) Drug Court has been available for most people that are charged in Multnomah County with a felony drug possession crime. The objective for STOP Court is to significantly reduce drug abuse within the community. Throughout the years, STOP Court has assisted in the reduction of harm from the use of controlled substances and a reduction in recidivism within the community.

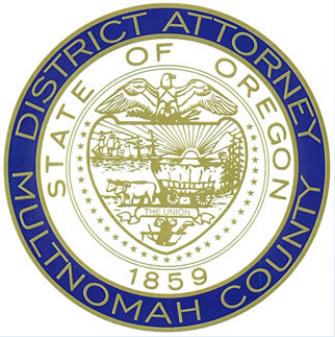

TREATMENT FIRST PROGRAM MISSION & PURPOSE

- “We are further aware of the fact that a very significant disproportionate number of persons of color are being arrested and referred to, and inserted into, the criminal justice system for these offenses. We endeavor to reduce the negative impact of criminal justice involvement and its associated collateral consequences and embrace a “treatment first” philosophy.”

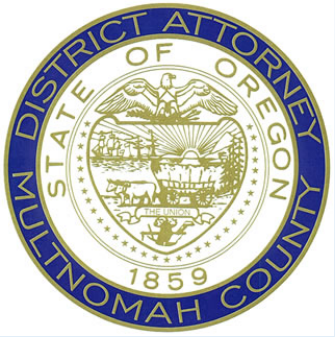

TREATMENT FIRST PROGRAM

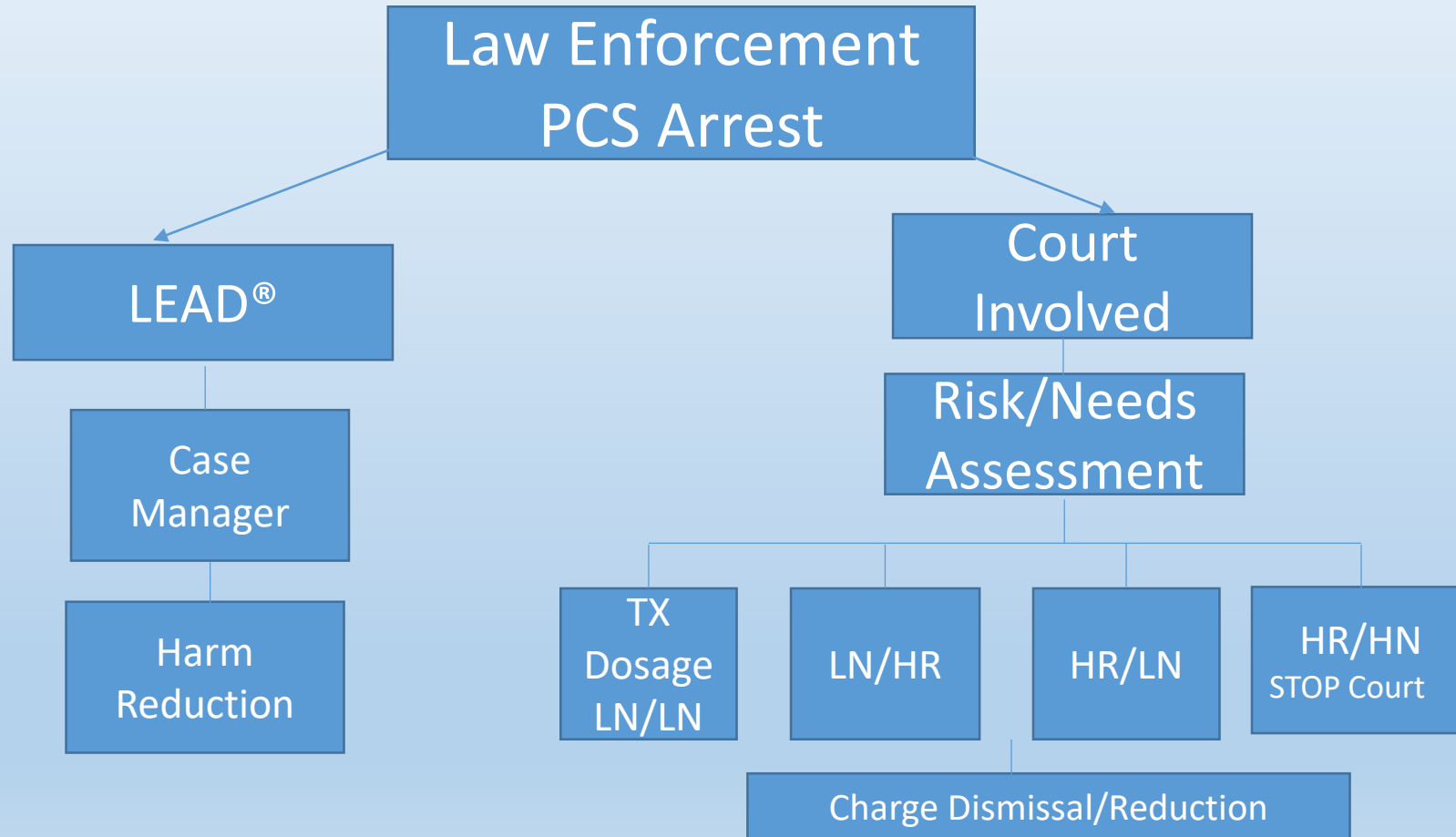
- Applies to all Possession of a Controlled Substance (PCS) issued cases
- Tier 1 – Reduced/charged at issuing as a misdemeanor (about 95%)
- Tier 2 – Issued as a felony (CDO/SQ)
- Opportunity to be assessed (LS/CMI) before case disposition
- Tailored supervision and treatment to the individual based on detailed assessment of risk and needs
- Individualized treatment response (dosage)
- HR/HN- STOP Court participants
- Opportunity for dismissal or reduction

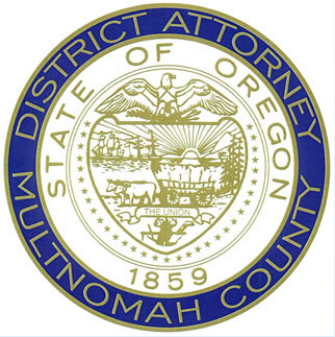

What is LEAD®?

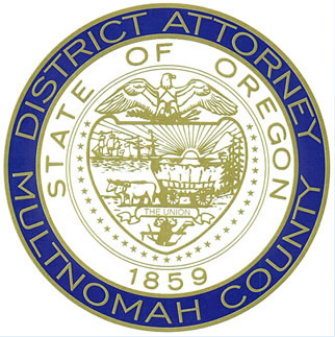
- LEAD® is a pre-booking harm reduction program.
- LEAD® allows officers to redirect low level offenders engaged in drug activity to services and resources specific to the needs of the individual instead of jail and prosecution.
- LEAD® participants begin working immediately with case managers to access services.
- There are currently about 140 individuals in the LEAD® program.

LEAD®'s Goals Include:

- Reduce the harm a drug offender causes him or herself and to the surrounding community
- Provide services to individuals experiencing addiction or abuse of a controlled substance
- Reduce recidivism rates for low-level offenders
- Decrease the number and negative impact of persons from communities of color being arrested and referred for prosecution for these offenses.
