Overview: HB 2946 (2017)



House Bill 2946 was passed during the 2017 legislative session.

As a result, *many new data and informational* reporting requirements were added to the Oregon Transparency Program Website.

Examples include but are not limited to:

Links to the ***revenues, budgets, and expenditures from all:***

Quasi-Public Entities:

Semi-independent agencies, public corporations (for profit and not for profit), and insurance entities.

Higher Education Entities:

Community colleges, universities, and university programs.



HB 2946 (2017) and ORS 276A.253 (7)(a)



ORS 276A.253 (7)(a): For the purpose of providing transparency in the revenues, expenditures and budgets of the following entities, the State Chief Information Officer shall include on the Oregon transparency website a page that provides links to websites established by:

- (A) Local governments, as defined in ORS 174.116[, and by].
- (B) Special government bodies, as defined in ORS 174.117[, for the purpose of providing transparency in the revenues, expenditures and budgets of the local governments and special government bodies].
- (C) Semi-independent state agencies listed in ORS 182.454.
- (D) Public universities listed in ORS 352.002.
- (E) Public university statewide programs operated by a public university listed in ORS 352.002.
- (F) The Oregon Health and Science University.
- (G) The Oregon Tourism Commission.
- (H) The Oregon Film and Video Office.
- (I) The Travel Information Council.
- (J) The Children's Trust Fund of Oregon Foundation.
- (K) Oregon Corrections Enterprises.
- (L) The State Accident Insurance Fund Corporation.
- (M) The Oregon Utility Notification Center.
- (N) Any public corporation created under a statute of this state and specifically designated as a public corporation.





Who Are Higher Education Entities?

Higher Education Entities include: community colleges, universities, and university programs.

Per HB 2946 *"For the purpose of providing transparency in the revenues, expenditures and budgets of the following entities, the State Chief Information Officer shall include on the Oregon transparency website a page that provides links to websites established by:"*

Community Colleges, Universities, and University Programs, per sections (7)(a)(B), (D) and (E).





HB 2946: Implementation Process: Higher Education

Prior to requesting data and informational links as noted in HB 2946, initial discussions were conducted.

Composite reports consisting of the *data and informational links* that were provided by community colleges, universities, and university programs as mentioned in HB 2946 were created.

HB 2946: Higher Education University Programs: Reporting Challenges



Challenges identified when requesting data from university programs include:

1. Interpretation of the terminology in the bill, and what is actually required
2. Interpretation of the terminology in the bill, and level of detail required
3. Variation in reporting format for each university program

Currently, discussions with the university programs related to these reporting challenges continue.



Summary



Working to implement HB 2946 has moved Oregon Transparency forward and provides greater visibility and access to data and information.

Transparency is not static but *Interactive and Transformative*.

Additional support and resources are needed to both maintain our current level of Oregon Transparency and achieve future goals.
