APPOINTMENT/CONFIRMATION AUTHORITY: ORS 675.775

STATEMENT OF ECONOMIC INTEREST (ORS 244.050): Not required

STATUTORY QUALIFICATIONS: ORS 675.775

Affirmative action policy: See ORS 182.100. Diversity criteria: See ORS 236.115.

- Eight members appointed by the Governor to three-year terms including:
 - Three must be licensed as professional counselors (**DALTON, McGRATH, THOMSON**)
 - Two must be licensed as marriage and family therapists (**MICHAELS, SALAZAR**)
 - One must be from the faculty of a school within this state that has programs to train persons to become professional counselors or marriage and family therapists (**REES**)
 - Two must be members of the public (**ALEXANDER, HOWARD**)
- A board member shall be removed immediately from the board if, during the member's term, the member:
 - Is not a resident of this state;
 - Has been absent from three consecutive board meetings, unless at least one absence is excused;
or
 - Is not a licensee or a retired licensee whose license was in good standing at the time of retirement, if the board member was appointed to serve on the board as a licensee.

DUTIES AND AUTHORITY: ORS 675.785

- Adopt rules
- Impose nonrefundable fees in an amount set by rule for the following:
 - License application
 - First issuance of a license
 - Renewal of a license
 - (Late filing of a license renewal
 - Renewal of registration as an intern
 - Examinations
- The board shall maintain a register of all current licensed professional counselors and marriage and family therapists and publish a directory listing all current licensed professional counselors and marriage and family therapists.
- Investigate alleged violations, establish procedures to review and investigate the complaints of clients of licensees of the board

- Report to the Legislative Assembly concerning the activities of the board during the preceding biennium.
- Establish, examine and pass on the qualifications of applicants to practice professional counseling or marriage and family therapy in this state.
- The board shall grant licenses to applicants who qualify to practice professional counseling or marriage and family therapy in this state
- The board will adopt code of ethics for licensees. The board may use the ethical codes of professional counseling and marriage and family therapy associations as models for the code established by the board
