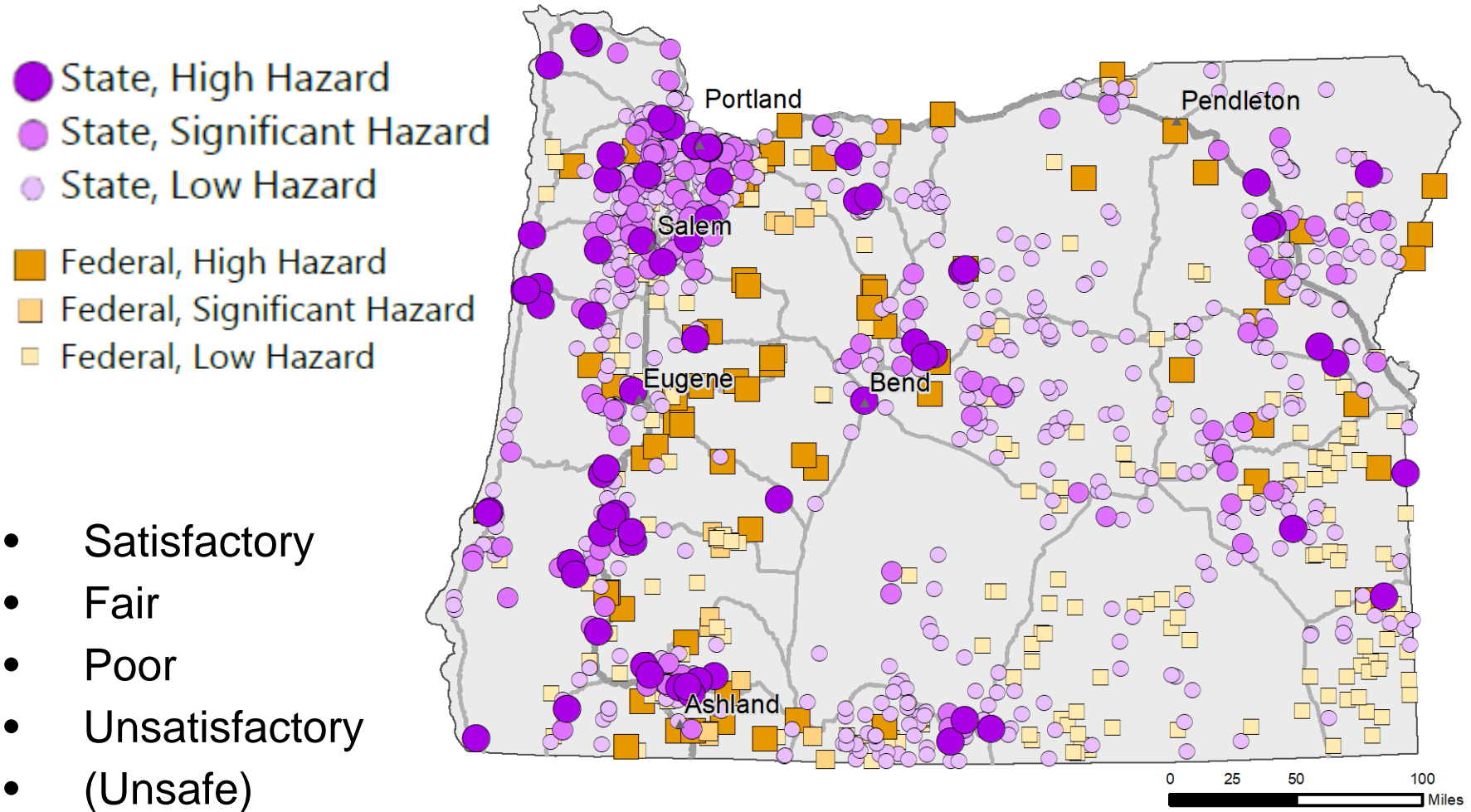


Dam Safety Program

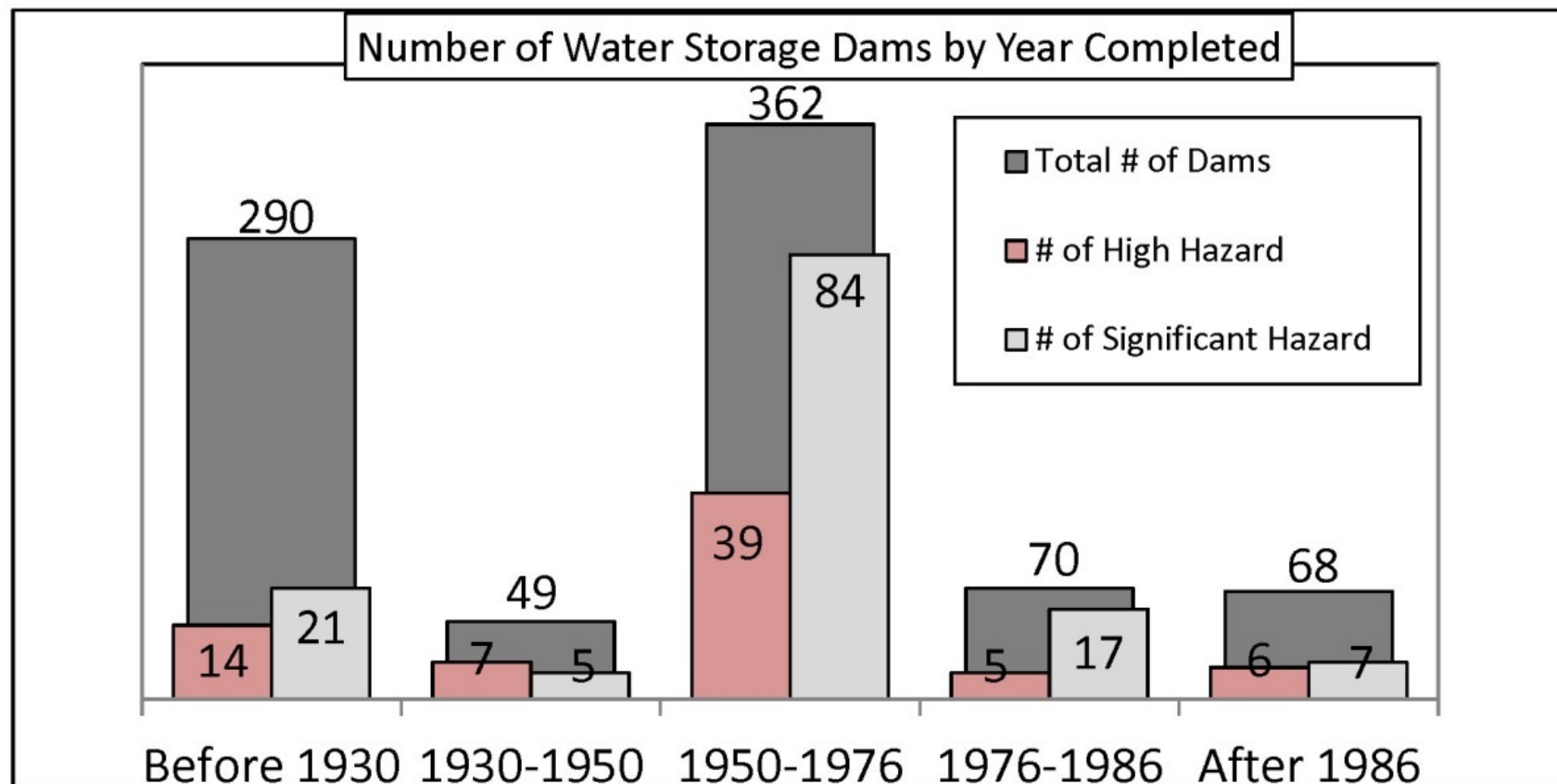
- **1929 - life and property**
- **10 feet high and 3+ million gallons**
- **Inspect dams and require repairs for safety**
- **Review designs for new dams and significant modifications**
- **Emergency Action Plans for high-hazard dams**

Condition of High-Hazard Dams and Costs: Caveats

- **Specific costs are difficult to ascertain without a full-scale engineering analysis for each individual dam**
- **Insufficient resources to conduct more in-depth assessments of dams; inspections are only visual in nature**
- **All costs are estimates**

Funding Resources

- **Limited options: particularly for non-federally regulated dams, and especially non-publically owned**
 - FEMA National Dam Rehabilitation Program
 - USDA Watershed Rehabilitation Program
 - Oregon Special Public Works Fund
 - **Other funding programs may be able to fund dam rehabilitation in some instances, but not targeted for that purpose**
- **Conclusion: Funding is a challenge; costs can be significant**

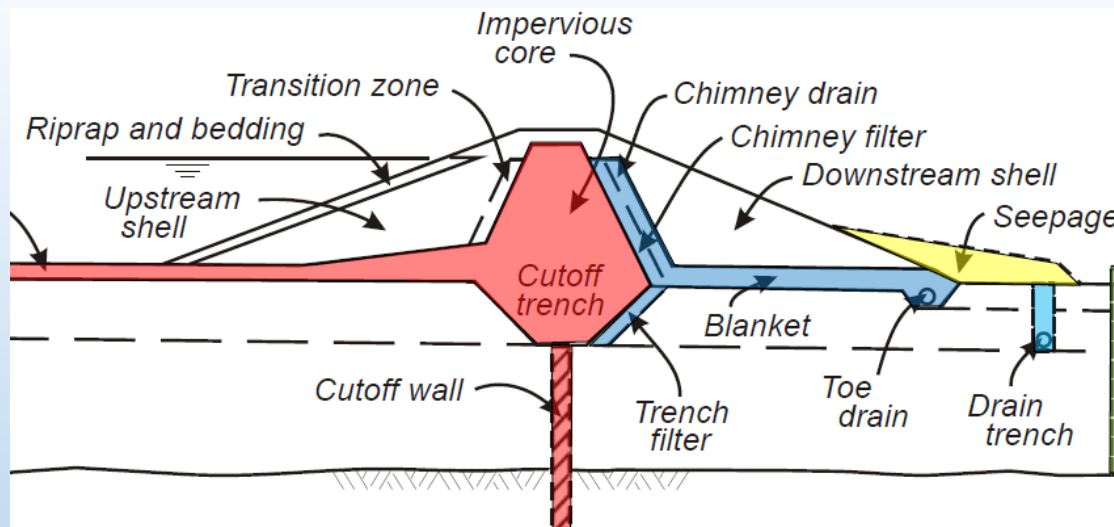
- 1. Modernize state laws to improve the safety and resiliency of Oregon dams**
- 2. Resources to determine safety deficiencies; evaluate and retrofit**
- 3. Authorize emergency actions and encourage cooperative actions to improve the safety of dams**



- 4. Properly decommission dams at the end of their useful life**
- 5. Coordinate emergency responses**
- 6. Define the responsibilities of a dam owner**
- 7. Require monitoring on deficient high-hazard dams**



8. Dam owners should prepare an EAP for high hazard dams
9. Authorize a fee for review of plans and specifications
10. Dedicate grant and loan resources for rehabilitation of deficient dams



Potential Legislative Concept

- **See attachment**
- **Jurisdiction – Non-federally regulated dams: water or wastewater**
- **Approval of modifications and receipt of final engineering documentation**
- **Fee for reviews of plans for dams**
- **Guidance for owners on their responsibilities**
- **Clarify the Department's general authorities and actions may take during a dam failure**

Potential Legislative Concept

- **Approval of removals to protect people and property**
- **Improve process for maintenance and safety issues, including flood and seismic; Provide tools to work with owners and get compliance**
- **Civil penalty authority for certain violations of dam safety statutes**
- **In order to improve readability and functionality of the statutes, repeals the current laws; as a result many existing authorities appear as new language**
