HB 2023

CARRIED OVER FROM THE 4-13-2017 AGENDA: Amends definition of "high-value farmland." Declares emergency, effective on passage.

HB 3432

CARRIED OVER FROM THE 4-13-2017 AGENDA: Makes permissive rather than mandatory provision that noncompliant survey map that is not corrected by surveyor and returned to county surveyor within 30 days be forwarded by county surveyor to State Board of Examiners for Engineering and Land Surveying for action.

HB 2029

Modifies definition of "native fish" for purposes of salmon and trout enhancement program.

Sets forth full name of state agency in statute.

HB 2035 **

**Subsequent Referral(s) to Ways and Means

Requires State Department of Fish and Wildlife to develop and implement program to provide technical assistance to Oregon landowners, businesses and communities regarding nonlethal methods to reduce conflict between humans and wildlife.

HB 2098

Requires Department of State Lands to conduct study on effectiveness of removal-fill laws and submit report on results of study to interim committees of Legislative Assembly related to environment and natural resources on or before September 15, 2018.

HB 3235 **

**Subsequent Referral(s) to Ways and Means

Appropriates moneys from General Fund to State Department of Agriculture to fund grant program for weed control districts.

**Subsequent Referral(s) to Ways and Means

CARRIED OVER FROM THE 4-13-2017 AGENDA: Authorizes issuance of lottery bonds to finance water storage projects and water distribution projects.

HB 2031

CARRIED OVER FROM THE 4-13-2017 AGENDA: Allows owner of land to receive liquidated damages in amount not to exceed \$1,000 in action in which owner establishes that owner closed land to specific activities and defendant entered upon land and engaged in prohibited activities without permission of owner.

HB 2094

CARRIED OVER FROM THE 4-13-2017 AGENDA: Requires counties and metropolitan service districts that propose land for designation as urban reserve or rural reserve in written agreement to in fact designate land if specified factors are decided in affirmative.

HB 2099

CARRIED OVER FROM THE 4-13-2017 AGENDA: Changes water management and conservation plan approval condition for extension of time to construct works or perfect right for municipal use of water.

HB 2214 **

**Subsequent Referral(s) to Ways and Means
CARRIED OVER FROM THE 4-13-2017 AGENDA: Establishes Expedited Housing Permitting Fund.

HB 2321

CARRIED OVER FROM THE 4-13-2017 AGENDA: Requires boat operators to drain all standing or captured water before leaving water access site or riparian zone.

HB 2371

CARRIED OVER FROM THE 4-13-2017 AGENDA: Specifies that, for purposes of statutes regulating seeds, agricultural hemp seed is flower seed.

HB 2535 **

**Subsequent Referral(s) to Ways and Means

CARRIED OVER FROM THE 4-13-2017 AGENDA: Requires State Department of Agriculture to conduct fouryear pilot program for replacing noxious weeds that supply pollen and nectar to pollinating insects with noninvasive forage plants offering similar benefit for pollinating insects.

HB 2730

CARRIED OVER FROM THE 4-13-2017 AGENDA: Makes form and style changes to statute regarding responsibilities and powers of State Department of Agriculture.

HB 2786

CARRIED OVER FROM THE 4-13-2017 AGENDA: Exempts from requirements of removal-fill laws removal or fill, or both, of any lot or parcel not shown as having wetlands on Statewide Wetland Inventory.

HB 2883

CARRIED OVER FROM THE 4-13-2017 AGENDA: Permanently prohibits outfitter and guide who is convicted of violation of wildlife laws for unlawfully taking wildlife with culpable mental state from applying for or obtaining licenses, tags and permits under wildlife laws.

HB 2893

CARRIED OVER FROM THE 4-13-2017 AGENDA: Requires city to evaluate for inclusion in urban growth boundary agricultural land consisting predominantly of certain soil classifications with other first priority lands.

HB 3006

CARRIED OVER FROM THE 4-13-2017 AGENDA: Requires State Forestry Department to identify Oregon-based contractors qualified to provide wildfire fighting personnel, equipment and other resources.

HB 3012

CARRIED OVER FROM THE 4-13-2017 AGENDA: Permits owner of lot or parcel of at least two acres zoned for rural residential uses to construct new single-family dwelling on lot or parcel if owner converts existing historic home to accessory dwelling unit.

HB 3193 **

**Subsequent Referral(s) to Ways and Means

CARRIED OVER FROM THE 4-13-2017 AGENDA: Repeals Department of State Lands leasing requirements for kelp harvesting.

HB 3245

CARRIED OVER FROM THE 4-13-2017 AGENDA: Permits city to authorize planning commission or hearings officer to conduct hearings and make decisions on applications for amendments to city comprehensive plan.

HB 3338 **

**Šubsequent Referral(s) to Revenue

CARRIED OVER FROM THE 4-13-2017 AGENDA: Requires State Department of Agriculture to adopt rules
governing posting of tax information by gas stations.

HB 3425

CARRIED OVER FROM THE 4-13-2017 AGENDA: Requires that state goals for food fish management ensure that certain decisions be made in consideration of and proportionate with revenues generated by recreational and commercial fisheries for State Department of Fish and Wildlife.

HB 3429

CARRIED OVER FROM THE 4-13-2017 AGENDA: Clarifies definition of "covered animal species" for purposes of wildlife trafficking prevention program.

HJM 11

CARRIED OVER FROM THE 4-13-2017 AGENDA: Urges President and Congress to pursue Oregon and California Railroad grant land management reforms.

HB 2784

Directs State Department of Fish and Wildlife to conduct study on health of shellfish populations in this state.

HB 2866

Requires State Fish and Wildlife Commission to adopt certain requirements related to carcasses of returning hatchery fish.

HB 3053

Creates Task Force on Water Infrastructure Investment.

HB 3234

Directs State Department of Fish and Wildlife to conduct study on health of shellfish populations in this state.
