#### Public Hearing and Possible Work Session

HB 2857

CARRIED OVER FROM THE 4/12/2017 AGENDA: Prohibits certain activities by, and specifies additional duties for, performing rights society in notifying business proprietors concerning proprietors' duties with respect to performing copyrighted musical works and in negotiating contracts for paying royalties for performing copyrighted musical works.

#### Work Session

HB 3170

CARRIED OVER FROM THE 4/12/2017 AGENDA: Extends collective bargaining rights to certain faculty members of public university with academic rather than administrative focus.

HB 3264

CARRIED OVER FROM THE 4/12/2017 AGENDA: Directs contracting agency to pay small business within 15 days of receipt of invoice or due date for payment, whichever is later.

HB 3402

CARRIED OVER FROM THE 4/12/2017 AGENDA: Limits hours that nurses employed in Department of Corrections institutions may work.

HB 2169

CARRIED OVER FROM THE 4/12/2017 AGENDA: Limits certain attorney fee awards to employee who prevails on claim against employer in wage and hour and employment cases.

HB 2975

CARRIED OVER FROM THE 4/12/2017 AGENDA: Authorizes court to award retail customers of vehicle dealers statutory damages under certain circumstances.

HB 2191 \*\*

CARRIED OVER FROM THE 4/12/2017 AGENDA: Requires person to obtain or renew license from Secretary of State in order to serve as commercial registered agent in this state.

HB 2348 \*\*

CARRIED OVER FROM THE 4/12/2017 AGENDA: Increases amount of revenue from business registry filings that Secretary of State dedicates to operations of office of Secretary of State from \$20 per filing to \$25 per filing.

## **AGENDA (Cont.)**

### **April 14, 2017**

- HB 2356  
CARRIED OVER FROM THE 4/12/2017 AGENDA: Establishes requirements under which debt buyer may bring legal action to collect debt.
- HB 2567  
CARRIED OVER FROM THE 4/12/2017 AGENDA: Requires employers with 75 or more employees to provide 60 days' notice to employees and certain officials before ceasing operations, relocating or ordering mass layoff involving 50 or more employees.
- HB 2112  
Prohibits financial institutions from unilaterally closing customer account unless customer is given 60 days' notice of closure and of reason for closure.
- HB 2162 \*\* \*\*Subsequent Referral(s) to Ways and Means  
Requires state contracting agency that awards public improvement contract with contract price of more than \$5 million to require contractor to employ apprentices to perform 10 percent of work hours on public improvement that workers in apprenticeable occupations perform.
- HB 2163  
Permits employer to make deduction from employee's wages for contribution to individual account for employee's benefit in plan maintained under section 125, 401(k), 403(b), 408, 408A or 457 of Internal Revenue Code if employee is given certain notices and right to cancel or change contribution.
- HB 3305  
Includes travel trailers as vehicles that are subject to state's "lemon law."  
Declares emergency, effective on passage.

#### **Possible Work Session**

- HB 2190  
Modifies definition of "social game" for purposes of regulation of gambling.
- HB 2907  
Provides that specialized building inspector authorized by, but not employed by, municipality to administer and enforce parts of state building code specialty code is appointee of municipality for purpose of inspector certification statutes.
- HB 3146  
Specifies that wage requirements for certain economic development programs must be determined with respect to permanent positions.
- HB 3189  
Establishes Department of Building Codes.
- HB 3299  
Imposes on owner of foreclosed residential real property liability to local government of \$10 for each day that property remains unsold and vacant during period that begins 270 days after date of trustee's sale or judgment of foreclosure, unless owner demonstrates that property remains unsold and vacant because owner is renovating or substantially remodeling property.
- HB 3396  
Requires communications service providers, Internet service providers and television service providers to provide customers with written confirmation of verbally agreed upon rate, term or condition of service within 10 days of verbal agreement.
