Directs State Registrar of Center for Health Statistics to send to Department of Consumer and Business Services each calendar quarter names of children born in Oregon to residents of this state.
- HB 3367 \*\* \*\*Subsequent Referral(s) to Ways and Means  
Directs State Registrar of Center for Health Statistics to send to State Treasurer each calendar quarter names of children born in Oregon to residents of this state.
