Public Hearing

- HB 3276 ** **Subsequent Referral(s) to Ways and Means
CARRIED OVER FROM 3/24/2017 AGENDA: Requires health benefit plan coverage of health services necessary to combat disease outbreak or epidemic.
- HB 2931
Clarifies educational requirements for registration of behavior analysis interventionists.
- HB 3085 ** **Subsequent Referral(s) to Revenue
Establishes Health Care Professional Training Fund.
- HB 3261
Requires Oregon Health Authority, in collaboration with Office of Rural Health, to develop uniform application for all health care provider financial incentive programs and collect information from participants in programs.
- HB 3345
For purposes of Oregon Indoor Clean Air Act, expands definition of "public place" to include common areas of commercial residential buildings and residential buildings with two or more rental units.

Work Session

- HB 2114
Prohibits issuing initial prescription for opioids or opiates to adults for outpatient use in quantity exceeding seven-day supply.
- HB 2388
Requires Department of Consumer and Business Services to deny, revoke or suspend authority of pharmacy benefit manager to conduct business in Oregon if pharmacy benefit manager fails to comply with applicable statutes, rules or orders.
