#### Public Hearing

- HB 3086  
Requires health benefit plan to reimburse cost of treatment for HIV-associated lipodystrophy.
- HB 3268 \*\*  
Repeals provisions directing Public Utility Commission to administer residential telecommunication service program. \*\*Subsequent Referral(s) to Ways and Means

#### Public Hearing and Possible Work Session

- HB 3363  
Changes term "osteopath" to "osteopathic physician." Clarifies that doctors of osteopathic medicine practice medicine as physicians.

#### Work Session

- HB 2114  
CARRIED OVER FROM 3/27/2017 AGENDA: Prohibits issuing initial prescription for opioids or opiates to adults for outpatient use in quantity exceeding seven-day supply.
- HB 2388  
CARRIED OVER FROM 3/27/2017 AGENDA: Requires Department of Consumer and Business Services to deny, revoke or suspend authority of pharmacy benefit manager to conduct business in Oregon if pharmacy benefit manager fails to comply with applicable statutes, rules or orders.
- HB 2339  
Prohibits health care provider or participating health care facility from balance billing patient covered by health benefit plan or health care service contract for services provided at participating health care facility.
- HB 2882  
Requires governing body of coordinated care organization to include representative from at least one dental care organization that serves members of coordinated care organization.
