- HB 3418  
Modifies methodology for reimbursement of health care services and supplies provided to enrollees in health benefit plans offered by Public Employees' Benefit Board.
- HB 3355  
Authorizes State Board of Psychologist Examiners to issue certificate of prescriptive authority to licensed psychologist who meets specified requirements.

Reinstates tax credit for long term care insurance premiums.

#### Work Session

- HB 2339  
CARRIED OVER FROM 4/3/2017 AGENDA: Prohibits health care provider or participating health care facility from balance billing patient covered by health benefit plan or health care service contract for services provided at participating health care facility.
- HB 2301  
Specifies circumstances under which Health Licensing Office is required or permitted to disclose information obtained during investigation of certain professions.
- HB 2645 \*\* \*\*Subsequent Referral(s) to Ways and Means  
Directs each manufacturer of certain types of drugs that are sold within this state to develop and implement drug take-back program for purpose of collecting from individuals and nonbusiness entities those types of drugs for disposal.
