#### Public Hearing

- HB 3353  
Directs education providers to mail written notice before conducting dental screening on students at location associated with education provider.
- HB 2979  
Eliminates certain categories of medical assistance recipients from exemption from enrollment in coordinated care organization.
- HB 2044  
Prohibits Oregon Health Authority from recovering state's share of overpayment of medical assistance for prescription drug unless overpayment resulted from fraud.
- HB 2045  
Authorizes Oregon Health Authority to waive or reduce inadvertent or unintentional overpayment of medical assistance claim for prescription drug.
- HB 2310  
Modifies provisions regarding schedule by which local public health authorities must submit local plans for applying foundational public health capabilities and implementing foundational public health programs.

#### Work Session

- HB 2393  
Specifies case manager's duties in event that case manager receives notice that person for whom case manager provides services will have life-sustaining procedures withheld or withdrawn.
- HB 2518  
Requires pharmacy to report de-identified information to prescription monitoring program upon dispensing prescribed naloxone.
- HB 2931  
Clarifies educational requirements for registration of behavior analysis interventionists.
- HB 3363  
Changes term "osteopath" to "osteopathic physician." Clarifies that doctors of osteopathic medicine practice medicine as physicians.
