#### Public Hearing and Possible Work Session

HB 2778

Prohibits insurer, Public Employees' Benefit Board and Oregon Educators Benefit Board from offering benefit plans that require prior authorization or increased cost-sharing for specified health care services if cost of services is reimbursed by plan.

HB 2836

Requires Oregon Health Authority to conduct study of effectiveness of Oregon Integrated and Coordinated Health Care Delivery System in improving health outcomes for medical assistance recipients.

HB 3428

Enrolls specified public employees in coordinated care organizations.

HB 3439

Requires that in professional corporation that is organized to allow physicians, physician assistants and nurse practitioners to jointly render professional health care services, physicians, physician assistants or nurse practitioners must hold majority of voting shares and be majority of directors of professional corporation.

HB 2122 \*\*

\*\*Subsequent Referral(s) to Ways and Means

CARRIED OVER FROM 4/12/2017 AGENDA: Modifies requirements for coordinated care organizations in 2018 and 2023.

HB 2300

CARRIED OVER FROM 4/12/2017 AGENDA: Requires cost of mental health drugs to be taken into consideration in determining global budgets for coordinated care organizations.

HB 2503 \*\*

\*\*Subsequent Referral(s) to Ways and Means

CARRIED OVER FROM 4/12/2017 AGENDA: Directs Health Licensing Office to issue lactation consultant and lactation educator licenses to qualified applicants.

#### HB 2580

CARRIED OVER FROM 4/12/2017 AGENDA: Exempts foster children and homeless youth from requirement to enroll in coordinated care organization in order to receive medical assistance.

HB 2834

CARRIED OVER FROM 4/12/2017 AGENDA: Requires Oregon Health Authority to conduct study of effectiveness of Oregon Integrated and Coordinated Health Care Delivery System in improving health outcomes for medical assistance recipients. \*\*Subsequent Referral(s) to Ways and Means

HB 3276 \*\*

CARRIED OVER FROM 4/12/2017 AGENDA: Requires health benefit plan coverage of health services necessary to combat disease outbreak or epidemic. \*\*Subsequent Referral(s) to Ways and Means

#### HB 3352 \*\*

CARRIED OVER FROM 4/12/2017 AGENDA: Establishes Task Force on Funding for School Behavioral Health Support.

#### HB 3415

CARRIED OVER FROM 4/12/2017 AGENDA: Imposes requirements upon mental health treatment providers and programs to ensure culturally and linguistically appropriate care for individuals who are deaf or hard of hearing.

HB 2839

Prohibits eye bank, tissue bank, procurement organization, hospital or physician from considering any disability of potential recipient of anatomical gift and from requiring individual with disability to demonstrate ability to perform major life activity substantially limited by disability upon receiving anatomical gift.

#### HB 3080

Establishes Task Force on State Medical Assistance Funding. HB 3083 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Requires Director of Department of Consumer and Business Services to convene task force to study and make recommendations for improving and stabilizing health insurance exchange. \*\*Subsequent Referral(s) to Ways and Means

HB 3084 \*\*

Requires Department of Consumer and Business Services to administer program to provide financial assistance with cost of deductibles and other cost-sharing requirements associated with health insurance.

HB 3097

Requires Oregon Health Authority to study barriers to residents applying for medical assistance.

#### HB 3080. HB 3083, HB 3084 and HB 3097 are scheduled for work sessions for the purpose of subsequent referral to House Rules Committee.

HB 2015

Directs Oregon Health Authority to reimburse doula at rate of no less than \$350 per pregnancy for services provided to medical assistance recipient.

HB 2342

Updates Insurance Code provisions applicable to health insurance in accordance with federal requirements.

HB 2392

Modifies requirements for health benefit plan coverage of hearing loss treatments.

HB 2518

Requires pharmacy to report de-identified information to prescription monitoring program upon dispensing prescribed naloxone.

HB 2527

Allows pharmacists to prescribe and dispense self-administered hormonal contraceptives. \*\*Subsequent Referral(s) to Ways and Means

HB 2664 \*\*

Specifies criteria for licensing of extended stay centers and requires Oregon Health Authority to adopt rules. HB 2838

Requires Oregon Health Authority to take specific steps to improve assistance provided to individuals applying for or seeking to renew medical assistance eligibility.

HB 3090

Requires hospital to apply discharge policy for release of patients admitted to hospital for mental health treatment to release of patients from emergency department following treatment for behavioral health crisis.

### AGENDA (Cont.) April 14, 2017

HB 3091

Requires specified facilities to provide certain case management and behavioral health services to individual who presents at facility experiencing behavioral health crisis.

HB 3181

Provides that statement from parent or guardian releasing student seven years of age or younger from requirement to submit certification that student received dental screening within previous 12 months may include explanation of reason that student has not received dental screening.

HB 3135

Requires medical assistance coverage of long-acting, reversible contraceptive devices during hospital stay for labor and delivery.

HB 3261

Requires Oregon Health Authority, in collaboration with Office of Rural Health, to develop uniform application for all health care provider financial incentive programs and collect information from participants in programs.

- HB 3268 \*\* \*\*Subsequent Referral(s) to Ways and Means Repeals provisions directing Public Utility Commission to administer residential telecommunication service program.
- HB 3353

Directs education providers to mail written notice before conducting dental screening on students at location associated with education provider.

HB 3355

Authorizes State Board of Psychologist Examiners to issue certificate of prescriptive authority to licensed psychologist who meets specified requirements.

HB 3391 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Requires health benefit plan coverage of specified health care services, drugs, devices, products and procedures related to reproductive health.

HB 3418

Modifies methodology for reimbursement of health care services and supplies provided to enrollees in health benefit plans offered by Public Employees' Benefit Board.
