#### Public Hearing

- HB 2315 \*\* \*\*Subsequent Referral(s) to Revenue  
Provides that corporate excise tax credit allowed to lenders that finance affordable housing is not barred by receipt of housing vouchers by tenants.
- HB 2964 \*\* \*\*Subsequent Referral(s) to Revenue  
Extends ad valorem property tax exemption to existing qualified dwelling units of single-unit housing purchased by taxpayers seeking exemption.
- HB 3005 \*\* \*\*Subsequent Referral(s) to Revenue  
Creates refundable credit against personal income taxes for housing rental payments.
- HB 2912 \*\* \*\*Subsequent Referral(s) to Ways and Means  
Establishes Affordable Housing Land Acquisition Revolving Loan Fund Program within Housing and Community Services Department to make loans to eligible organizations to purchase land for affordable housing development and to provide supportive services to residents and low income households.
- HB 3357 \*\* \*\*Subsequent Referral(s) to Ways and Means  
Increases amount of fees charged and collected by county clerks to record or file certain real property documents.
- HB 2433 \*\* \*\*Subsequent Referral(s) to Ways and Means  
Directs Housing and Community Services Department to establish pilot program in which department constructs low-income senior housing development on school district land and school district rents to low-income seniors at reduced rent in exchange for classroom assistance.

#### Work Session

- HB 2010  
Establishes Task Force on Addressing Racial Disparities in Home Ownership.
- HB 2002  
Expands laws regarding preservation of participating properties that are publicly supported housing.
- HB 2316  
Requires city with population of less than 25,000 to determine estimated housing need for 20-year period, inventory buildable land and adopt measures as part of periodic or legislative review of comprehensive plan.

**March 21, 2017**

- HB 2401  
Requires Department of Human Services and Department of Justice to provide trauma-informed training and curriculum to child welfare personnel.
- HB 3261  
Requires Oregon Health Authority, in collaboration with Office of Rural Health, to develop uniform application for all health care provider financial incentive programs and collect information from participants in programs.
- HB 3275  
Requires applicant for housing development containing at least 100 new housing units to give notice to Department of Education and school district.
- HB 2347  
Extends for two years Department of Human Services' authority to prescribe employability assessment and orientation process for job opportunity and basic skills program and limit number of participants and activities of participants in program; to require single parent of child under two years of age to participate in job opportunity and basic skills program; to deny request of recipient in temporary assistance for needy families program to enroll in educational institution as allowable work act
