Public Hearing

- HB 2961 ** **Subsequent Referral(s) to Ways and Means
Establishes Homeownership Repair and Rehabilitation Program within Housing and Community Services Department to provide grants to eligible nonprofit organizations to provide financial assistance to persons in low income households for repair and rehabilitation of residences.
- HB 2996 ** **Subsequent Referral(s) to Revenue
Designates Act as Oregon First-Time Home Buyer Savings Account Act.
- HB 3192 ** **Subsequent Referral(s) to Revenue then to Ways and Means
Establishes Homeownership Down Payment Assistance Program within Housing and Community Services Department to provide grants to eligible nonprofit organizations, housing authorities and local governments to provide financial assistance to first-time home buyers in low income households.
- HB 2210 ** **Subsequent Referral(s) to Ways and Means
Directs Housing and Community Services Department to develop and implement Retaining Affordable Rental Housing Program to provide grants to owners of multifamily rental housing to rehabilitate and maintain housing at affordable rental rates.
- HB 3175
Makes changes to definition of "low income households" in Local Innovation and Fast Track Housing Program.

Work Session

- HB 2456
Permits tax exempt landowner to develop affordable housing units on rural residential land with county approval.
- HB 3012
Permits owner of lot or parcel of at least two acres zoned for rural residential uses to construct new single-family dwelling on lot or parcel if owner converts existing historic home to accessory dwelling unit.
- HB 2937
Permits accessory dwelling unit on land zoned rural residential and as conditional permitted use on land zoned for exclusive farm use.
