Public Hearing

- SB 59 B
Authorizes court to remove fiduciary, or modify powers or authority of fiduciary, on motion of Long Term Care Ombudsman.
- SB 948 A
Prohibits residential facility from employing, in publicly funded position, individual found to have committed type of abuse that is disqualifying under rules adopted by Department of Human Services.
- SB 1027 A
Prohibits Department of Human Services and Oregon Health Authority from seeking payment from amounts in ABLE account.

Work Session

- SB 104
Modifies provisions relating to registry of persons who provide care in certain facilities.
- SB 244 A
Establishes notification requirements of Department of Human Services regarding reported or suspected abuses, deficiencies, violations or failures of child-caring agency to comply with full compliance requirements and regarding reports of suspected or substantiated abuse of child in care.
- SB 245
Modifies definitions of "child" and "child-caring agency."
Declares emergency, effective on passage.
- SB 760
Removes requirement, for abuse reporting purposes, that contact between public or private official and abused person or abuser be while acting in official capacity.
- SB 830
Changes definition of foster parent who is "current caretaker."
- SB 17
Removes requirement that superintendents of certain state institutions administered by Oregon Health Authority and Department of Corrections designate chief medical officer of institution.

AGENDA (Cont.)
May 4, 2017

- SB 821
Directs Oregon Housing Stability Council, with advice of Community Action Partnership of Oregon, to develop policy for awarding grants to organizations that shall use funds in Emergency Housing Account to align with federal strategies and resources available to prevent and end homelessness.
- SB 834 A
Requires Department of Human Services to develop and present proposal for creation of human rights commission to interim committees of Legislative Assembly related to human services and health no later than December 1, 2017.
- SB 949 A
Makes noncompetition agreement or certain covenant with home care worker voidable by home care worker.
