HB 2955

Provides that person commits crime of strangulation if person knowingly impedes normal breathing or circulation of another person by applying pressure to chest of other person.

HB 2972

Prohibits public university, community college or Oregon-based private university or college to use threat of student discipline or other sanction to influence decision of victim of alleged incident of sexual assault, domestic violence or stalking regarding whether to report alleged incident or participate in investigation or adjudication of alleged incident.

HB 2988

Increases penalty for crime of harassment if offense consists of subjecting another person to offensive physical contact and is committed in immediate presence of or witnessed by minor child in specified circumstances.
