#### Public Hearing and Work Session

- HB 2545  
Allows deception detection examination administrator to proctor deception detection examination.
- HB 2807  
Directs State Court Administrator to study most common types of lawsuits brought in Oregon courts and report to appropriate committee or interim committee of Legislative Assembly no later than September 1, 2018.
- HB 2812  
Directs Department of Human Services and Oregon Youth Authority to conduct statewide study regarding juveniles no later than July 1, 2018.
- HB 2826  
Requires court to impose mandatory minimum sentence of imprisonment if person is convicted of crime of fleeing or attempting to elude police officer under certain circumstances.
- HB 3078 \*\*  
Modifies eligibility for Family Sentencing Alternative Pilot Program. \*\*Subsequent Referral(s) to Ways and Means
- HB 3274  
Expands exemption from public records law of records of Office of Small Business Assistance, and directs office to maintain specified records confidentially.

- HB 2171 \*\*  
CARRIED OVER FROM THE 4/11/2017 AGENDA: Requires Oregon Volunteers Commission for Voluntary Action and Service to maintain volunteer staff of court appointed special advocates sufficient to meet statutory requirement to appoint court appointed special advocate in every juvenile dependency proceeding. \*\*Subsequent Referral(s) to Ways and Means
- HB 2308  
CARRIED OVER FROM 4/11/2017 AGENDA: Provides that in calculation of maximum period of commitment for defendant lacking fitness to proceed, defendant must receive credit for each day defendant is held in jail.
- HB 2597  
CARRIED OVER FROM THE 4/11/2017 AGENDA: Renames offense of operating motor vehicle while using mobile communication device as offense of operating motor vehicle while using mobile electronic device.

- HB 2630  
CARRIED OVER FROM THE 4/11/2017 AGENDA: Makes changes to Oregon guardianship laws to assure adequate safeguards for respondents and protected persons.
- HB 2740  
CARRIED OVER FROM THE 4/11/2017 AGENDA: Increases age of trafficked person from 15 to 18 for crime of trafficking in persons for use in commercial sex act.
- HB 2794  
CARRIED OVER FROM THE 4/11/2017 AGENDA: Reduces penalties for crime of possession of gambling records in the second degree.
- HB 3279  
CARRIED OVER FROM THE 4/11/2017 AGENDA: Modifies definition of "labor contractor" to include property services contractor.
- HB 2322  
Renames position of State Medical Examiner to Chief Medical Examiner.
- HB 2360  
Modifies reporting obligation for sex offenders by requiring report within 10 days following change of residence.
- HB 2472 \*\*  
Directs State Medical Examiner to assume counties' responsibilities related to death investigations. \*\*Subsequent Referral(s) to Ways and Means
- HB 2633  
Expands definition of "sex offender" for purposes of sex offender treatment services.
- HB 2986  
Modifies provisions relating to administration of estates.
- HB 3077  
Requires court, upon request of crime victim, to order that victim's electronic mail address and social media account identifying information not be given to defendant unless good cause is shown.
- HB 3364  
Permits payment of up to \$3,000 in emergency assistance over consecutive 12-month period on behalf of child whose parent is victim of domestic violence or at risk for domestic violence.
- HB 3380 \*\*  
Modifies eligibility for Family Sentencing Alternative Pilot Program. \*\*Subsequent Referral(s) to Ways and Means
- HB 2793  
CARRIED OVER FROM THE 4/11/2017 AGENDA: Decreases penalties for crime of cheating.  
*HB 2793 will not be heard Wednesday, April 12. It is scheduled for the sole purpose of being carried over to the Thursday, April 13 agenda.*
