HB 3266

CARRIED OVER FROM THE 4/13/2017 AGENDA: Provides that no person may use mechanical restraint, chemical restraint, prone restraint, physical restraint or seclusion on student in public education program.

HB 3449

HB 2171 **

CARRIED OVER FROM THE 4/13/2017 AGENDA: Requires Oregon Volunteers Commission for Voluntary Action and Service to maintain volunteer staff of court appointed special advocates sufficient to meet statutory requirement to appoint court appointed special advocate in every juvenile dependency proceeding.

HB 2217

CARRIED OVER FROM THE 4/13/2017 AGENDA: Creates Falk-Alfano Act.

HB 2238 **

**Subsequent Referral(s) to Ways and Means CARRIED OVER FROM THE 4/13/2017 AGENDA: Reduces crime classification of unlawful possession of controlled substance in Schedule I. Punishes by maximum of one year's imprisonment, \$6,250 fine, or both, except in specified circumstances.

HB 2308

HB 2360

CARRIED OVER FROM THE 4/13/2017 AGENDA: Modifies reporting obligation for sex offenders by requiring report within 10 days following change of residence.

HB 2380

CARRIED OVER FROM THE 4/13/2017 AGENDA: Creates crime of threatening a mass injury event. **Subsequent Referral(s) to Ways and Means HB 2472 **

CARRIED OVER FROM THE 4/13/2017 AGENDA: Directs State Medical Examiner to assume counties' responsibilities related to death investigations.

HB 2545

CARRIED OVER FROM THE 4/13/2017 AGENDA: Allows deception detection examination administrator to proctor deception detection examination.

HB 2593

CARRIED OVER FROM THE 4/13/2017 AGENDA: Requires that sexually explicit material involving minor remain in control of law enforcement agency or court throughout criminal proceeding or juvenile delinquency proceeding, provided that material is made reasonably available to defendant.

HB 2597

CARRIED OVER FROM THE 4/13/2017 AGENDA: Renames offense of operating motor vehicle while using mobile communication device as offense of operating motor vehicle while using mobile electronic device.

HB 2598

CARRIED OVER FROM THE 4/13/2017 AGENDA: Expands offense of vehicular assault to include contact with motorcycle, motorcycle operator or motorcycle passenger. HB 2600 **

CARRIED OVER FROM THE 4/13/2017 AGENDA: Transfers authority over court appointed special advocates and CASA Volunteer Programs from Oregon Volunteers Commission for Voluntary Action and Service to Oregon Criminal Justice Commission.

HB 2613

CARRIED OVER FROM THE 4/13/2017 AGENDA: Expands offense of driving while under influence of intoxicants to include any drug that adversely affects person's physical or mental faculties to noticeable or perceptible degree.

HB 2614

CARRIED OVER FROM THE 4/13/2017 AGENDA: Allows for blood test to be taken to determine presence of controlled substances or inhalants for purpose of Motorist Implied Consent Law.

HB 2620

CARRIED OVER FROM THE 4/13/2017 AGENDA: Expands crime of assault in the third degree to include physical injury to person working in hospital while worker is performing official duties.

HB 2625

CARRIED OVER FROM THE 4/13/2017 AGENDA: Provides that forfeiture petition may be filed for animal impounded pending outcome of animal crime even if specific animal is not named in charging instrument.

HB 2629

CARRIED OVER FROM THE 4/13/2017 AGENDA: Provides that if district attorney presents documentary evidence of medical service charges at restitution hearing, evidence creates rebuttable presumption that charges are reasonable.

HB 2630

HB 2698

CARRIED OVER FROM THE 4/13/2017 AGENDA: Allows person with other convictions within previous 10 years to file motion to set aside conviction after three years from date of judgment if other convictions were part of same criminal episode as conviction that is subject of motion.

HB 2732

CARRIED OVER FROM THE 4/13/2017 AGENDA: Provides that person who enters motor vehicle to remove child or animal in imminent danger of suffering harm is not subject to criminal or civil liability if person meets certain requirements.

HB 2740

CARRIED OVER FROM THE 4/13/2017 AGENDA: Increases age of trafficked person from 15 to 18 for crime of trafficking in persons for use in commercial sex act.

HB 2776

CARRIED OVER FROM THE 4/13/2017 AGENDA: Authorizes appointment of guardian for person with disability who is in need of guardianship.

HB 2793

CARRIED OVER FROM THE 4/13/2017 AGENDA: Decreases penalties for crime of cheating.

HB 2794

CARRIED OVER FROM THE 4/13/2017 AGENDA: Reduces penalties for crime of possession of gambling records in the second degree.

HB 2807

CARRIED OVER FROM THE 4/13/2017 AGENDA: Directs State Court Administrator to study most common types of lawsuits brought in Oregon courts and report to appropriate committee or interim committee of Legislative Assembly no later than September 1, 2018.

HB 2812

CARRIED OVER FROM THE 4/13/2017 AGENDA: Directs Department of Human Services and Oregon Youth Authority to conduct statewide study regarding juveniles no later than July 1, 2018.

HB 2817

CARRIED OVER FROM THE 4/13/2017 AGENDA: Corrects inaccurate reference to definition.

HB 2826

CARRIED OVER FROM THE 4/13/2017 AGENDA: Requires court to impose mandatory minimum sentence of imprisonment if person is convicted of crime of fleeing or attempting to elude police officer under certain circumstances.

HB 2986

CARRIED OVER FROM THE 4/13/2017 AGENDA: Modifies provisions relating to administration of estates. HB 3049

CARRIED OVER FROM THE 4/13/2017 AGENDA: Provides that person may not operate unmanned aircraft system so that unmanned aircraft system hovers over privately owned premises of another for more than 60 seconds.

HB 3077

CARRIED OVER FROM THE 4/13/2017 AGENDA: Requires court, upon request of crime victim, to order that victim's electronic mail address and social media account identifying information not be given to defendant unless good cause is shown. **Subsequent Referral(s) to Ways and Means

HB 3078 **

CARRIED OVER FROM THE 4/13/2017 AGENDA: Modifies eligibility for Family Sentencing Alternative Pilot Program.

HB 3109

CARRIED OVER FROM THE 4/13/2017 AGENDA: Directs court to include in judgment \$50 warrant service fee when imposing sentence on defendant arrested on warrant.

HB 3152

CARRIED OVER FROM THE 4/13/2017 AGENDA: Directs Oregon Business Development Department to issue loans or grants to Curry County to construct training facility for public safety personnel.

HB 3177

CARRIED OVER FROM THE 4/13/2017 AGENDA: Allows seizure, constructive possession and forfeiture of hens and chicks used in connection with cockfighting operation.

HB 3242

CARRIED OVER FROM THE 4/13/2017 AGENDA: Requires peace officer to electronically record interview with youth when investigating crime, or allegation that youth committed act that if committed by adult would constitute crime.

HB 3274

CARRIED OVER FROM THE 4/13/2017 AGENDA: Expands exemption from public records law of records of Office of Small Business Assistance, and directs office to maintain specified records confidentially.

HB 3279

CARRIED OVER FROM THE 4/13/2017 AGENDA: Modifies definition of "labor contractor" to include property services contractor.

HB 3283

CARRIED OVER FROM THE 4/13/2017 AGENDA: Amends findings by Legislative Assembly regarding provision of care and treatment for impounded or seized animals.

HB 3364

CARRIED OVER FROM THE 4/13/2017 AGENDA: Permits payment of up to \$3,000 in emergency assistance over consecutive 12-month period on behalf of child whose parent is victim of domestic violence or at risk for domestic violence.

HB 3380 **

**Subsequent Referral(s) to Ways and Means

CARRIED OVER FROM THE 4/13/2017 AGENDA: Modifies eligibility for Family Sentencing Alternative Pilot Program.

HB 3392

CARRIED OVER FROM THE 4/13/2017 AGENDA: Establishes state policies and judicial practices regarding blindness in individuals who are parents, prospective parents or caretakers of children in domestic relations cases and juvenile dependency proceedings.

HB 3438

CARRIED OVER FROM THE 4/13/2017 AGENDA: Directs Oregon Criminal Justice Commission to study reentry services and support and report results to interim committees of Legislative Assembly related to judiciary on or before September 15, 2018.

HB 3446
