HB 2280

Repeals disused statute granting right to any person assessed for property taxes to demand official certificate of assessment and fining assessor \$100 for refusal in action before county justice of peace.

HB 2281

Provides that disqualification of land designated as forestland shall be deemed to occur as of January 1 assessment date of assessment year in which discovery occurs, regardless of when discovery actually occurs.

HB 2277

Requires county governing body to apply property tax refund first as credit against amount due of total tax liability account on which tax was assessed, except in certain cases.

HB 2278

Authorizes municipal corporation to budget for estimated debt service payments when general obligation bonds are approved by voters at May election.
