#### Public Hearing and Possible Work Session

- SB 313 \*\* \*\*Subsequent Referral(s) to Ways and Means  
Directs Arts Program to study issues relating to outcomes of arts education.
- SB 538 \*\* \*\*Subsequent Referral(s) to Ways and Means  
Directs Oregon Business Development Department, in collaboration with Department of Consumer and Business Services, to conduct study regarding state regulation of businesses and persons engaged in occupations.
- SB 1044  
Provides that lapse, suspension or revocation of certificate, license, permit or other form of Oregon Liquor Control Commission authorization related to alcoholic beverages does not divest commission of authority for investigation, disciplinary proceedings and changes to suspension or revocation of certificate, license, permit or other authorization.
- SB 1049  
Increases maximum container capacity for dispensing alcoholic beverages into securely covered containers supplied by consumer.
- SB 1051  
Prohibits provision in instrument conveying real property that restricts use of real property as certified or registered family child care home.

#### Work Session

- SB 918  
Requires Department of Transportation to study improving this state's transportation system.
- SB 919  
Requires Department of Transportation to study improving this state's transportation system.
- SB 333  
Removes loan forgiveness and reimbursement delays and makes other changes to Oregon Industrial Site Readiness Program.

**AGENDA (Cont.)**  
**April 10, 2017**

- SB 374  
Authorizes Department of Transportation to issue driver licenses, driver permits and identification cards that meet requirements of federal Real ID Act of 2005.
- SB 664  
Prohibits agency from imposing civil penalty on small business for first violation of paperwork requirement if violation does not pose unreasonable risk of harm to employees of small business or general public.
- SB 753  
Exempts work performed on recreational vehicles from plumbing and electrical licensing requirements.
- SB 778  
Defines "just compensation" for purposes of laws related to outdoor advertising signs.
- SB 782  
Provides that Department of Transportation shall adopt rules that provide that manufacturer's certificate of ownership or manufacturer's bill of sale is valid evidence of vehicle ownership.
- SB 838  
Excludes persons who are not developers of timeshares from compliance with certain provisions governing timeshares.
- SB 930  
Specifies that registered owner of vehicle may black out or obscure residence address, business address, mailing address or vehicle address shown on registration card and on proof of insurance or other current proof of compliance.
- SB 983  
Eliminates electrician license category authorizing licensee to repair and maintain electrical wiring and equipment in manufactured structure.
