Public Hearing and Possible Work Session

- SB 170 ** **Subsequent Referral(s) to Tax Credits
Extends sunset for tax credit for energy conservation project.
- SB 177 ** **Subsequent Referral(s) to Tax Credits
Extends sunset for construction or installation of alternative energy devices.
- SB 933
Requires Real Estate Commissioner to adopt program to relieve pecuniary loss of landlord liable to tenant due to mismanagement by or dishonest conduct of real estate property manager.

Public Hearing

- SB 909
Specifies that public utility that makes sales of electricity may not establish rate for any service that provides public utility with rate of return that exceeds 4.5 percent.

Work Session

- SB 454 ** **Subsequent Referral(s) to Ways and Means
Directs Department of Transportation to establish Columbia River Gorge National Scenic Area highway improvement program.
- SB 885
Modifies provision allowing waiver of qualification for registration as professional engineer if applicant has professional engineering experience in another jurisdiction.
- SB 978
Prohibits electric company from including in its rates cost of electric generation resource or energy storage resource that is capable of generating electricity or storing electricity for not less than five years and has generating or storage capacity of 50 megawatts or more unless electric company must acquire resource to maintain reliability of electrical company's electrical system.

April 17, 2017

- SB 979
Establishes ability of retail electricity consumer to purchase electricity generated by eligible renewable energy resources and certain ancillary services directly from entity that is not distribution utility that meets specified conditions.
- SB 980
Requires motor vehicle manufacturers, distributors and importers to reimburse dealers for service related to vehicle recall at same rate as warranty work.
- SB 982
Regulates business relationship between equipment suppliers and equipment dealers in this state.
- SB 985
Exempts insurers that transact certain classes of commercial insurance from requirement to file rates or policy forms.

Note change: SB 933 has been added. SB 968 has been deleted.
