SB 186

Validates land use designations adopted by Metro and counties within Metro, with exceptions.

#### Public Hearing and Possible Work Session

SB 958

Conditions issuance of certain Department of State Lands permit on balancing test that weighs potential environmental harm of proposed project against public need.

#### Work Session

SB 1007

CARRIED OVER FROM THE 4-12-2017 AGENDA: Directs State Department of Energy to develop climate test to conduct reviews for approval of proposed fossil fuel infrastructure projects.

SB 1037

CARRIED OVER FROM THE 4-12-2017 AGENDA: Allows local government to inhibit or prevent production or use of seed or seed products for purpose of protecting seed or products that are not genetically engineered from adverse impacts of genetically engineered seed or products or if enforcing local measure approved by county voters on May 20, 2014.

SB 1048

CARRIED OVER FROM THE 4-12-2017 AGENDA: Permits city or county to adjust property line through progression of property line adjustments that incorporates further adjustments of adjusted properties.

SB 197 \*\*

\*\*Subsequent Referral(s) to Ways and Means

CARRIED OVER FROM THE 4-12-2017 AGENDA: Requires Environmental Quality Commission to adopt by rule program for regulating air contaminant emissions from dairy confined animal feeding operations.

SB 865

CARRIED OVER FROM THE 4-12-2017 AGENDA: Requires county or city governing body to submit subdivision or partition plats to certain special districts for district approval prior to approval by governing body.

**AGENDA (Cont.)**  
**April 13, 2017**

- SB 892  
CARRIED OVER FROM THE 4-12-2017 AGENDA: Requires filing notice with State Forestry Department of proposed aerial application of pesticide as planned forest management activity on privately owned forestland.
- SB 871  
CARRIED OVER FROM THE 4-12-2017 AGENDA: Makes changes to program requiring asbestos survey to have been conducted before demolishing residence or residential building.
- SB 643  
Requires persons 17 years of age or younger and who are operating boat, or who are passengers in boat, on section of waters rated class III or higher to wear helmet.
- SB 929  
Requires State Department of Agriculture to classify neonicotinoids as restricted use pesticides.
- SB 1036  
Provides that certain activities at landfills are not considered surface mining and are exempt from surface mining permit requirements of State Department of Geology and Mineral Industries.

**Possible Work Session**

- SB 836  
Redefines "de minimis level" for purposes of Toxic-Free Kids Act.
