Work Session

SB 215 **

**Subsequent Referral(s) to Ways and Means

Directs Oregon Health Authority to establish and operate statewide database for collection and dissemination of orders for rare disease emergency response medical treatment for purpose of ensuring safe treatment of individuals with rare diseases in emergency situations.

SB 367

Permits health care provider to disclose protected health information of inmate of correctional facility to employee of correctional facility who is exposed to bodily fluids of inmate if exposure is substantial and inmate has tested positive for HIV, hepatitis B or C or other communicable disease.

SB 368

Prohibits insurer from denying claim for reimbursement of health care services provided to insured who is in detention facility pending adjudication by juvenile court.

SB 423

Allows physician assistants to dispense controlled substances in schedules III and IV under federal Controlled Substances Act.

Public Hearing and Possible Work Session

SB 46

Removes authority of Department of Consumer and Business Services to enforce specified health benefit plan coverage requirements applicable to Public Employees' Benefit Board and Oregon Educators Benefit Board.

Public Hearing

SB 786

Requires health care regulatory boards to allow health care practitioner to use telehealth when health care practitioner determines telehealth is appropriate.

- SB 783
Requires insurers to have user-friendly procedures for enrollees and providers to access coverage information and request prior authorization for health benefit plans offered by insurers.
- SB 784
Requires insurer to reimburse out-of-network women's health care provider at same rate as in-network women's health care provider.
