Work Session

- SB 217
Allows chiropractic physicians and naturopathic physicians to provide release for athlete who sustained concussion or is suspected of sustaining concussion.
- SB 856
Allows naturopathic physicians to perform certain actions that physicians are authorized to perform.
- SB 485 **
**Subsequent Referral(s) to Business and Transportation
Exempts, under specified conditions, for-profit or nonprofit business entity from requirement that licensed physicians hold majority of voting stock in professional corporation organized for purpose of practicing medicine or be majority of directors of professional corporation.
- SB 861
Removes, for health care facilities that receive preponderance of revenue from associated comprehensive group-practice prepayment health care service plans, exemption from financial data reporting required by Oregon Health Authority for other facilities.
- SB 808
Provides that with respect to health screen testing for newborns, Oregon Health Authority shall specify that health testing service may conduct tests for conditions listed on most recent edition of Recommended Uniform Screening Panel by United States Department of Health and Human Services.
- SB 233
Requires Oregon Health Authority to make publicly available specified information regarding administration of medical assistance and payments to coordinated care organizations.
- SB 234
Requires Oregon Health Authority to renew coordinated care organization contract for another five-year term if specified conditions are met.
- SB 793
Requires prescription drug manufacturer to report to Department of Consumer and Business Services prices and increases in prices of manufacturer's prescription drugs sold in Oregon.

SB 235 **

**Subsequent Referral(s) to Ways and Means

Provides that person may not make retail sale of tobacco product or inhalant delivery system at or from premises located in this state unless person sells tobacco product or inhalant delivery system at or from premises for which license has been issued.

Public Hearing and Work Session

SB 998

Provides that person may not make retail sale of tobacco product or inhalant delivery system at or from premises located in this state unless person sells tobacco product or inhalant delivery system at or from premises that has been registered.

HB 2304

Adds peer support specialist, family support specialist and youth support specialist to membership of Traditional Health Workers Commission.
