The work session on HB 2015 A is scheduled solely for the purpose of sending it back to the Senate President's Office to request rereferral to the Joint Committee on Ways and Means.

Work Session

- HB 2015 A
Directs Oregon Health Authority, in coordination with Traditional Health Workers Commission, to biennially review, and revise if necessary, any reimbursement rates for doulas.
- HB 2339 A
Prohibits health care provider or participating health care facility from balance billing patient covered by health benefit plan or health care service contract for services provided at participating health care facility.
- HB 2398 A
Prohibits health care provider from billing medical assistance applicant or recipient except as provided by Oregon Health Authority by rule.
- HB 2839 A
Prohibits entities providing health care services, practitioners practicing health care professions and insurers of health care services from, solely on basis that individual who meets eligibility requirements for receipt of organ transplant is disabled, discriminating against individual with respect to practices related to and coverage of organ transplant.
- HB 2527 A
Allows pharmacists to prescribe and administer injectable hormonal contraceptives and prescribe and dispense self-administered hormonal contraceptives.
- HB 3363 A
Changes term "osteopath" to "osteopathic physician." Clarifies that doctors of osteopathic medicine practice medicine as physicians.
- HB 3014 A
Requires applicants for initial license to practice respiratory therapy to hold credential as Registered Respiratory Therapist.
