Possible Introduction of Committee Measures

SB 101 ** **Subsequent Referral(s) to Judiciary
Authorizes child abuse investigation or interview of child who is subject of child abuse report on private as well as public school premises.

Possible Work Session

SB 340
Prohibits adoption or enforcement of local ordinance or regulation prohibiting or limiting use of accessory dwelling unit under certain circumstances.

SB 434 ** **Subsequent Referral(s) to General Government and Accountability then to Ways and Means
Creates Task Force on Wildfire Damage Financial Relief.

SB 462 ** **Subsequent Referral(s) to Tax Credits
Provides credit against income taxes for taxpayer donating to Oregon Project Independence Fund.

SB 594 ** **Subsequent Referral(s) to Tax Credits
Restores availability of tax credit for employment-related child care expenses and extends credit sunset.

SB 310
Authorizes city or county to designate area within jurisdiction as vertical housing development zone.

Public Hearing

SB 262
Establishes timelines by which evaluations must be completed to determine eligibility for special education.

SB 263
Limits school district's ability to require students to participate in abbreviated school day program.

SB 363 ** **Subsequent Referral(s) to Ways and Means
Directs Department of Education to conduct study on methods for improving safety of work environments for staff involved in special education and related services.

**Subsequent Referral(s) to Judiciary

Establishes automatic restraining order against petitioner in Family Abuse Prevention Act proceeding that restrains petitioner from directly or indirectly causing respondent to violate certain terms of Family Abuse Prevention Act order.
