SB 53

CARRIED OVER FROM THE 3/6/2017 AGENDA: Modifies licensing fees paid to Oregon Health Authority by inhome care agencies and hospice providers.

SB 104

CARRIED OVER FROM THE 3/6/2017 AGENDA: Modifies provisions relating to registry of persons who provide care in certain facilities.

SB 275

CARRIED OVER FROM THE 3/6/2017 AGENDA: Permits covered entity to deny request for copy of health information regarding individual who is appealing denial of Social Security disability benefits if requested by person other than individual or individual's personal representative without valid written authorization signed by individual.

SB 95 **

**Subsequent Referral(s) to Judiciary

Requires certain securities professionals to report suspected financial exploitation of elderly, disabled or vulnerable individual to Department of Consumer and Business Services and Department of Human Services.

SB 239 **

**Subsequent Referral(s) to Judiciary then to Ways and Means

Establishes process to determine consent of resident of residential care facility or adult foster home to individually based limitation of certain rights.

Public Hearing

SB 265 **

**Subsequent Referral(s) to Ways and Means

Directs Department of Human Services to conduct monthly, in-person visits with child or ward in substitute care that include updates on academic status and progress.

SB 749

Requires Department of Human Services to, upon request, reassign caseworker to child, ward, youth or youth offender who is 12 years of age or older and in legal custody of department.

SB 830

Changes definition of foster parent who is "current caretaker.".
