SB 263

CARRIED OVER FROM THE 4/5/2017 AGENDA: Limits school district's ability to require students to participate in abbreviated school day program.

- \*\*Subsequent Referral(s) to Ways and Means SB 1018 \*\* Establishes Oregon Deaf, Deaf-Blind and Hard of Hearing Program within Department of Human Services.
- SB 942

Directs Department of Human Services to conduct statewide study regarding child safety no later than July 1, 2018. SB 53

- Modifies licensing fees paid to Oregon Health Authority by in-home care agencies and hospice providers.
- SB 1027

Prohibits Department of Human Services and Oregon Health Authority from seeking payment from amounts in ABLE account.

SB 819

Expands parameters of duties and responsibilities of Critical Incident Response Team assigned by Department of Human Services upon becoming aware of fatality of child that was result of abuse or neglect. \*\*Subsequent Referral(s) to Judiciary

SB 268 \*\*

Requires Department of Human Services and law enforcement agencies to investigate reports of abuse that occurred at school or in educational setting or that are made by school employees. \*\*Subsequent Referral(s) to Ways and Means

SB 1023 \*\*

Establishes Deaf, Deaf-Blind and Hard of Hearing Fund.

#### **Public Hearing and Possible Work Session**

SB 1029 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Appropriates moneys from General Fund to Oregon Health Authority for Senior Farm Direct Nutrition Program and Women, Infants and Children Farm Direct Nutrition Program.

SB 948

Prohibits employment by publicly funded residential facility of individual found to have committed type of abuse that is disqualifying under rules adopted by Department of Human Services.
