SB 315

Authorizes court to order, at request of victim, special condition of probation restricting location of person's residence if person released on probation following conviction for felony stalking crime. SB 897 \*\*

Creates crime of militia terrorism.

SB 977

Voids noncompetition agreements except to extent that former employee may not contact former customer or client to provide similar product, process or service for six months after employee's date of separation.

SB 1050

Provides that presumptive sentence for certain sex crimes is life imprisonment without possibility of release or parole if defendant has certain prior conviction at time of offense.
