For **OMB** licensees only-please read the below because it impacts which evaluators you may use:

A * means approved by Oregon Medical Board for evaluations of OMB licensees BUT the Medical Board requires that OMB licensees be evaluated by providers licensed at the same level or above. E.g. MDs/DOs/DPMs may be evaluated by MDs/DOs, and PAs may be evaluated by PhDs or MDs, LACs may be evaluated by MDs, PhDs, or LCSW social workers. Evaluators of OMB MD/DO/DPM licensees with substance use disorders must be MDs or DOs with ASAM or ABAM Certification. Three stars means***also approved by Oregon Medical Board for evaluation of OMB acupuncturists and PAs.
