## A BILL FOR AN ACT

1

2 Relating to transportation.

3 **Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1. (1) The Department of Transportation shall study and**  
5 **make recommendations, and shall report, on options for improving**  
6 **highway infrastructure in this state.**

7 **(2) The department shall submit the report required by subsection**  
8 **(1) of this section, and may include recommendations for legislation,**  
9 **to the interim committees of the Legislative Assembly related to**  
10 **transportation in the manner provided under ORS 192.245 no later than**  
11 **September 15, 2018.**

12 **SECTION 2. Section 1 of this 2017 Act is repealed on January 2, 2020.**
