Establishes Task Force on Trade Promotion. Requires task force to study methods for increasing trade in products and services from Oregon businesses by promoting exports of Oregon products outside United States.

A BILL FOR AN ACT

- 2 Relating to trade; and declaring an emergency.
- 3 Be It Enacted by the People of the State of Oregon:
- 4 SECTION 1. (1) The Task Force on Trade Promotion is established.
 - (2) The task force consists of seven members appointed as follows:
 - (a) The President of the Senate shall appoint two members from among members of the Senate.
 - (b) The Speaker of the House of Representatives shall appoint two members from among members of the House of Representatives.
 - (c) The Governor shall appoint three members as follows:
- 11 (A) One member from the Oregon Business Development Depart-12 ment;
 - (B) One member from a large Oregon business that exports Oregon products outside the United States; and
- 15 (C) One member from a small Oregon business that exports or in-16 tends to export Oregon products outside the United States.
- 17 (3) The task force shall study methods for increasing trade in pro-18 ducts and services from Oregon businesses by promoting Oregon pro-19 ducts and services for export outside the United States.

- 1 (4) The task force may consult experts, hear testimony and conduct 2 research that is necessary to enable the task force to carry out the 3 purposes set forth in subsection (3) of this section.
 - (5) A majority of the members of the task force constitutes a quorum for the transaction of business.
 - (6) Official action by the task force requires the approval of a majority of the members of the task force.
- 8 (7) The task force shall elect one of its members to serve as chair-9 person.
- 10 (8) If there is a vacancy for any cause, the appointing authority
 11 shall make an appointment to become immediately effective.
- 12 (9) The task force shall meet at times and places specified by the 13 call of the chairperson or of a majority of the members of the task 14 force.
- 15 (10) The task force may adopt rules necessary for the operation of the task force.
- 17 (11) The task force shall submit a report in the manner provided 18 by ORS 192.245, and may include recommendations for legislation, to 19 an interim committee of the Legislative Assembly related to trade no 20 later than September 15, 2018.
- 21 (12) The Oregon Business Development Department shall provide 22 staff support to the task force.
- 23 (13) Members of the task force who are not members of the Legis-24 lative Assembly are not entitled to compensation or reimbursement 25 for expenses and serve as volunteers on the task force.
- (14) All agencies of state government, as defined in ORS 174.111, are directed to assist the task force in the performance of the task force's duties and, to the extent permitted by laws relating to confidentiality, to furnish information and advice the members of the task force consider necessary to perform their duties.
- SECTION 2. Section 1 of this 2017 Act is repealed on December 31,
