HB 2859

I am writing this letter in concerns to the additional tax that will incur with the passage of this bill.

I am a fourth generation farmer that is training and wanting to pass on my skills and success next generation staying in agriculture and hopefully many more.

I feel the pendulum has been swung too far to the left on agriculture. Between zoning, port trade, labor, rules, regulation and now taxes you will force us out of business. Agriculture producers have always been price takers and not price makers. We have always had to learn to get by and survive with what the market allows us to make. We are not allowed to go get I owe you's when our equity runs out. Why does the State and the Federal Government not learn to do this? We cannot make promises we cannot keep without consequences. Where do we get this attitude that the public is owed and entitled to everything? I have always been taught you reap the rewards of what you sow.

Agriculture is not in the position to be able to generate more income to cover the additional taxation that the state seems to think they need. Based on the numbers that I have seen published Oregon is the second highest tax per person in the Northwest behind California. Where is all this money going?

Agriculture through the taxation of land and many other misc. taxes already pays more than is fair share. Agriculture and natural resources businesses have very little voting say on how that money is spent. It is not right that we put most of the burden of the natural resources that are privately held just because they are the minority and be out voted but pay the majority of the tax in the country.
