Dear Chair Hass and members of the Committee on Finance and Revenue:

I write on behalf of Oregon Opportunity Network (Oregon ON), the statewide association of affordable housing and community development nonprofits, to urge your support for SB 1. Oregon ON strongly supports SB 1, which will create an income tax credit for the operation costs of housing for agricultural workers.

Oregon ON is proud to be a lead partner in the Agricultural Workforce Housing Coalition, a diverse group of agriculture, housing, and community groups who are working together with the shared goals of supporting a strong agricultural economy <u>and</u> providing safe, decent affordable housing for the families who put food on our tables.

Oregon ON's housing authority and community development members, from Forest Grove to Medford, from McMinnville to Ontario, are currently providing safe, stable, affordable community-based housing for farmworkers and their families – and we would like to provide more homes, to meet the huge unmet need around the state.

The Agricultural Workforce Housing Operations Tax Credit created by SB 1 is a new income tax credit modeled on the existing Agricultural Workforce Housing Tax Credit. The existing credit, which supports the development of housing for our agricultural workforce, is efficient, effective, and fully subscribed.

The new credit will preserve and create additional housing options for agricultural workers by incentivizing existing owners of on-farm housing to preserve and improve their housing. In addition, for community-based organizations like Oregon ON's members, this will create new opportunities to leverage existing and new sources of capital to create more housing in rural communities.

Safe, decent housing means fewer workers are homeless or live in inhumane conditions. For farmworker families, as for all families, children's success in school and life is tied to having a stable home. We know that we are currently meeting only a small percentage of the need statewide. This leaves families and workers sleeping in cars, under bridges, or in fields. Or, it means that growers don't have workforce available when the crops are ripe. Please support SB 1 and provide additional, much-needed support for agricultural workforce housing.

Thank you very much for your consideration, and for the opportunity to testify in support of SB 1.
