Dear Chair Paul Holvey and other committee members,

We write to show our support for House Bill 2975. This bill addresses a major problem: Oregon consumers are buying cars from dealers and not receiving title. When people buy a car, they either pay in full or get financing. Either way, dealers are paid in full for the cars they sell.

Dealers frequently do not have title to the vehicles they sell because they purchase the cars on credit. The money they receive for the car they sold should be used to satisfy the prior lien on the title, but it frequently is not. If the dealer fails to pay off the lien the title never gets delivered to the consumer. The law already requires dealers to pay off the lien and deliver title in about 30 days¹. Sometimes the dealers do what the law requires and they pay the lien and deliver the title within days. Other times it takes a couple of months. We have seen it take over six months or in some cases over a year.

This is not a new problem and it is one that is already regulated. The DMV receives complaints and fines dealers if they are not following the rules. The DMV prints a quarterly magazine and lists dealer sanctions in every edition. We have included as Exhibit A the dealer sanction pages from the 2011 edition to present and highlighted all of the violations related to titling. Unfortunately for consumers, an overwhelming majority of dealer violations are related to title issues. What this shows is that dealers are not deterred by DMV regulations.

The attached Exhibit B includes complaints to the Department of Justice (DOJ) made in 2016 concerning failure to deliver title. The DOJ is not the agency that handles these types of issues, but they received 37 complaints last year alone. This indicates the prevalence of the problem.

Our practice is limited to helping consumers who are victims of fraud perpetrated by car dealers. We regularly receive phone calls from consumers who have not received title to cars they have purchased. We regularly turn them away because they cannot afford, nor is it fair, to pay money for an attorney to obtain the title to the product they already paid for. This bill would allow more attorneys to represent consumers to obtain their titles.

We hope that this committee will see the merit in this bill and will vote to support and help Oregon consumers around the state.

Motorcycle standards strict

A motorcycle must be manufactured for on-road use in the U.S. to be registered for operation on Oregon roads. Though some states allow off-road motorcycles to be converted for on-road use, Oregon does not.

Imported motorcycles must have a Manufacturer's

Imported motorcycles must have a Manufacturer's Certificate of Origin (MCO) that states the vehicle was manufactured for on-road use.

When an MCO does not state the vehicle was manufactured for on-road use, or that the motorcycle meets U.S. federal safety and emissions standards, an Oregon dealer can view the federal safety standards label. If the motorcycle only has a federal emissions label, it was not manufactured for on-road use. For more information on Oregon's requirements
