#### **Commission History**

The Oregon Law Commission (Commission) was created by the Oregon Legislative Assembly in 1997 to conduct a continuous process of law revision, reform, and improvement. (*See* ORS 173.315 to 173.357.) The Commission replaced its predecessor, the Law Improvement Committee, which had been inactive since 1990. Legislative appropriations supporting the Commission's work then began July 1, 2000. At that time, the State, through the Office of the Legislative Counsel, entered into a public-private partnership with Willamette University. Willamette University's College of Law currently provides executive, administrative, and legal research support for the Commission as well as its Work Groups. The College of Law also facilitates undergraduate, law student, and faculty participation in support of the Commission's work. The Commission will be relocating from Willamette University during summer 2017.

#### **Commission Membership**

In creating the Commission, the Legislative Assembly recognized the need for distinguished, knowledgeable, and respected individuals to lead complex law revision projects with an impartial approach. Accordingly, the Commission is composed of fifteen Commissioners. Oregon statute requires that the Commission include: four legislators, the Chief Justice of the Oregon Supreme Court, the Chief Judge of the Court of Appeals, a circuit court judge appointed by the Chief Justice, the Attorney General, a Governor appointee, the Dean of each of Oregon's three law schools, and three representatives of the Oregon State Bar. Former legislator, Lane P. Shetterly, serves as the Commission's Chair as he has since its inception. Former Attorney General Hardy Myers held the role of Vice-Chair as well as Program Committee Chair until his passing in the fall of 2016. Like Mr. Shetterly, Mr. Myers was an original member of the Commission. His quiet integrity, as a fellow Commissioner described it, is greatly missed.

#### **Commission Mission & Purpose**

The Commission serves the citizens of Oregon by working with key partners and stakeholders on complicated law reform projects. Law reform projects come to the Commission in myriad ways, including by legislator request, agency suggestion, Bar request, or even private citizens. In addition, the Commission's breadth of in-house expertise leaves no shortage of knowledge on needed reform projects. Potential projects go before the Commission's Program Committee for review. Once viable projects are identified, the Commission's staff researches the applicable areas of law, including gathering input from experts and those who may be affected by proposed reforms. The Commission via its Work Groups, Study Groups, etc., produce legislative measures, written reports, and recommendations regarding its projects. The Commission's Legislative Reports comprise crucial legislative history. Importantly, Legislative Reports describe a Work Group's decision-making process, any points of disagreement, and provide additional detail regarding intended meaning of law.

#### **Commission Future**

After 16 wonderful years at Willamette University College of Law, the Commission will be relocating to the University of Oregon School of Law (University) as of July 1, 2017. The University will provide academic, administrative and research resources to help assist and

strengthen the Commission's work. The partnership between the Commission and the University will be symbiotic in nature. The University has a long history of service and scholarship in public law and policy. This is a great opportunity for the State and Oregon's only public law school to join forces as partners in addressing key law reform issues.

#### **Commission Value**

The Commission is able to convene some of the brightest minds in Oregon to work on often complex and specialized law reform projects. It is difficult to quantify the true value of that volunteer service. However, in an effort to do so we estimated a minimal value on the Work Groups that produced the Commission's 2017 Session measures. The 2012 median hourly wage for Oregon attorneys was \$225 per hour. (*See* Economic Survey, Oregon State Bar, 2012.) Applying this outdated rate only to voting members of Work Groups and actual meeting times, plus one hour of preparation, we come up with the following conservative estimated values:

Direct Criminal Appeals: \$132,300 Receivership: \$160,650 Probate Modernization: \$299,250 **Total Value = \$592,200.00** 

Moreover, this estimated total value likely accounts for less than half of the actual value of each Work Group for three reasons: 1) There are many more "interested persons" who also volunteer their time and expertise; 2) Hours upon hours of additional work is done outside of formal Work Group meetings; and 3) This estimate does not account for Commission staff efforts.

# House Bill 5013

#### **SUMMARY**

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced.** 

Appropriates moneys from General Fund to Judicial Department for biennial expenses.

Limits biennial expenditures from fees, moneys or other revenues, including Miscellaneous Receipts and reimbursements from federal service agreements, but excluding lottery funds and other federal funds, collected or received by department.

Limits biennial expenditures by department from federal funds.

Appropriates moneys from General Fund to Judicial Department for Oregon Law Commission, Council on Court Procedures, conciliation and mediation services in circuit courts and law libraries. Declares emergency, effective July 1, 2017.

#### A BILL FOR AN ACT

Relating to the financial administration of the Judicial Department; and declaring an emergency.

Be It Enacted by the People of the State of Oregon:

SECTION 1. There are appropriated to the Judicial Department, for the biennium beginning July 1, 2017, out of the General Fund, the following amounts, for the following purposes:

Below is the preliminary budget estimate for the Oregon Law Commission (Commission) for the 2017-19 Biennium. As of July 1, 2017, the Commission will be housed at the University of Oregon School of Law (University). This budget enumerates the costs that the University will incur over the course of the 2017-19 Biennium. The University is restructuring the Commission to some degree in order to increase output while decreasing costs. The University will be providing the Commission with office space, student Fellows, and a senior Advisory Board all at no cost to the Commission. Additionally, the University will provide the Commission with limited support in accounting, IT, HR, facilities, and communications, all at a minimal expense intended only to cover increased transactional costs. Inclusive of the University's support, the total Biennium operating budget is estimated to be \$365,899.

This budget then also includes a line item for a new Commission staff attorney. (Policy Option Package 421). A staff attorney would allow the Commission to increase its output while also providing an enhanced focus on already-approved projects.

## Policy Option Package 420:

# **Provide for Estimated Expenses of Oregon Law Commission**

Companion Package: No.

#### **Purpose**

The Oregon Law Commission will be relocating to the University of Oregon School of Law as of July 1, 2017. The University of Oregon will be providing office space, a student Fellows program and senior Advisory Board services at no cost to the Commission. In addition, the law school will provide accounting, IT, human resources, facilities and limited communications support at minimal expense, intended only to cover increased transactional costs. Inclusive of the University's support, the total biennium operating budget is estimated to be \$365,899.

The existing Oregon Law Commission base funding, after including a 3.7% inflationary increase, leaves a direct expense gap in the amount of \$22,321. Accordingly, this package would close the gap between the current baseline funding and the direct expenses expected to be incurred by University of Oregon School of Law to house and staff the Oregon Law Commission.

#### **How Achieved**

The package provides additional funding to meet the difference between the anticipated direct costs (salary, benefits, and direct expenses) of the Oregon Law Commission and the current baseline funding amounts.

# Policy Option Package 421: Staff Attorney to Expand Capacity of Oregon Law Commission

Companion Package: No.

#### **Purpose**

This package would fund one FTE staff attorney for the Oregon Law Commission. A staff attorney would expand the Commission's ability to organize, coordinate, and staff projects for law reform in the state. The Commission has several approved projects that have been on hold pending capacity and some of these are quite large. The Commission would very much like to start Work Groups on these projects and possibly even increase output beyond. Increasing the Commission's workload, however, is not practical under the present budget framework. The addition of a staff attorney would permit the Commission to begin work on projects already in the queue while also expanding the commission's capacity to consider and manage other projects suggested by the public, state agencies, and members of the Legislative Assembly.

#### How achieved

The package would fund a base salary of approximately \$60,000, plus fringe benefits, including retirement, at the UO's standard benefit costs as well as a one-year cost of living increase. This position would be 1.0 FTE, with a two-year term.

### **Staffing impact**

Adds one FTE staff attorney.

#### **Revenue Source**

\$185.400 - General Fund
