

House Bill 3167

Sponsored by Representative HOLVEY, Senator BEYER

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Establishes Oregon Energy Commission as policy and rulemaking body for State Department of Energy. Transfers certain duties of State Department of Energy and Director of State Department of Energy to commission.

Modifies state energy policy.

Modifies general duties of department.

Requires department to develop statewide strategic energy plan. Requires commission to adopt plan no later than January 1, 2020. Requires department to present draft plan to Legislative Assembly no later than September 15, 2019. Requires commission to periodically review and update plan.

Requires department to provide biennial comprehensive energy report to Governor and Legislative Assembly.

Becomes operative January 1, 2018.

Declares emergency, effective on passage.

Be It Enacted by the People of the State of Oregon:

ENERGY POLICY

SECTION 1. ORS 469.010 is amended to read:

469.010. The Legislative Assembly finds and declares that:

(1) Continued growth in demand for [*nonrenewable energy forms*] **energy, at affordable cost,** poses a serious and immediate, as well as future, **concern.** [*problem. It is essential that future generations not be left a legacy of vanished or depleted resources, resulting in massive environmental, social and financial impact.*]

(2) It is the goal of Oregon to promote the efficient use of energy resources [*and to develop permanently sustainable energy resources. The need exists for comprehensive state leadership in energy production, distribution and utilization.*] **consistent with state environmental policy.** It is, there-

1 fore, the policy of Oregon:

2 (a) That **the** development and use of a diverse array of **affordable, sustainable energy re-**
 3 **sources be encouraged.** [*permanently sustainable energy resources be encouraged utilizing to the*
 4 *highest degree possible the private sector of our free enterprise system.*]

5 (b) That through state government example and **policy** [*other effective communications*], energy
 6 conservation and elimination of wasteful and uneconomical uses of energy and materials be pro-
 7 moted. [*This conservation must include, but not be limited to, resource recovery and materials recycl-*
 8 *ing.*]

9 [*(c) That the basic human needs of every citizen, present and future, shall be given priority in the*
 10 *allocation of energy resources, commensurate with perpetuation of a free and productive economy with*
 11 *special attention to the preservation and enhancement of environmental quality.*]

12 [*(d) That state government assist every citizen and industry in adjusting to a diminished avail-*
 13 *ability of energy.*]

14 [*(e) That energy-efficient modes of transportation for people and goods shall be encouraged, while*
 15 *energy-inefficient modes of transportation shall be discouraged.*]

16 (c) **That energy-efficient modes of transportation shall be encouraged.**

17 [(f)] (d) That cost-effectiveness, **balanced with environmental policy considerations**, be con-
 18 sidered in [*state*] agency decision-making relating to energy sources, facilities or conservation[, *and*
 19 *that cost-effectiveness be considered in all agency decision-making relating to energy facilities*].

20 [(g)] (e) That state government shall provide a source of impartial and objective information in
 21 order that this energy policy may be enhanced.

 23 **PROVISIONS RELATING TO THE OREGON ENERGY COMMISSION**

24
 25 **(Establishment)**

26
 27 **SECTION 2. Sections 3 and 5 of this 2017 Act are added to and made a part of ORS 469.010**
 28 **to 469.155.**

29 **SECTION 3. (1) There is created an Oregon Energy Commission. The commission shall**
 30 **consist of five voting members, appointed by the Governor and subject to confirmation by**
 31 **the Senate as provided in ORS 171.562 and 171.565.**

32 (2) **All voting members of the commission must be well informed in energy and climate**
 33 **issues and shall be appointed as follows:**

34 (a) **One member shall be an economist;**

35 (b) **One member shall have a higher education background;**

36 (c) **One member shall represent residential energy users;**

37 (d) **One member shall represent commercial and industrial energy users; and**

38 (e) **One member shall have transportation expertise.**

39 (3) **No voting member of the commission shall:**

40 (a) **Hold any pecuniary interest in any business entity conducting operations that, if**
 41 **conducted in this state, would be subject to the commission's regulatory jurisdiction; or**

42 (b) **Hold any pecuniary interest in, have any contract of employment with or have any**
 43 **substantial voluntary transactions with any business or activity subject to the commission's**
 44 **regulatory jurisdiction.**

45 (4) **One Oregon member of the Pacific Northwest Electric Power and Conservation Plan-**

1 ning Council shall serve as an ex officio, nonvoting member of the commission.

2 (5) The term of office of a voting member of the commission shall be four years, but the
3 members of the commission may be removed by the Governor. Before the expiration of the
4 term of a member, the Governor shall appoint a successor to assume the duties of the
5 member on July 1 of the next following year. A member shall be eligible for reappointment,
6 but no member shall serve more than two consecutive terms. In case of a vacancy for any
7 cause, the Governor shall make an appointment to become immediately effective for the
8 unexpired term.

9 (6) The commission shall select one of its members as chairperson and another as vice
10 chairperson, for terms and with duties and powers necessary for the performance of the
11 functions of the offices as the commission determines.

12 (7) A majority of the voting members of the commission constitutes a quorum for the
13 transaction of business.

14 (8) A member of the commission is entitled to compensation and expenses as provided in
15 ORS 292.495.

16 SECTION 4. Notwithstanding the term of office specified by section 3 of this 2017 Act,
17 of the voting members first appointed to the Oregon Energy Commission:

- 18 (1) One shall serve for a term ending January 1, 2019.
- 19 (2) One shall serve for a term ending January 1, 2020.
- 20 (3) One shall serve for a term ending January 1, 2021.
- 21 (4) Two shall serve for terms ending January 1, 2022.

22
23 (Functions, General Authority to Adopt Rules)
24

25 SECTION 5. (1) It is the function of the Oregon Energy Commission to establish the
26 policies for the operation of the State Department of Energy in a manner consistent with the
27 policy stated in ORS 469.010.

28 (2) In accordance with applicable provisions of ORS chapter 183, the commission shall
29 adopt rules and issue orders as necessary for the administration of the laws that the com-
30 mission, the Director of the State Department of Energy and the department are charged
31 with administering.

32 (3) Except as provided in ORS 183.335 (5), the commission shall cause a public hearing to
33 be held on any proposed rule or standard prior to its adoption. The hearing may be before
34 the commission, any designated member thereof or any person designated by and acting for
35 the commission.

36 (4) This section does not limit the authority granted the Energy Facility Siting Council
37 under ORS 469.300 to 469.563, 469.590 to 469.619, 469.930 and 469.992.

39 **TRANSFER OF RULEMAKING AUTHORITY FROM STATE**
40 **DEPARTMENT OF ENERGY TO OREGON ENERGY COMMISSION**

42 (Transfer)
43

44 SECTION 6. (1) Except as provided in subsection (2) of this section, the duties, functions
45 and powers of the State Department of Energy and the Director of the State Department of

1 Energy relating to the establishment of policy for the operations of the department and the
2 adoption of rules are imposed upon, transferred to and vested in the Oregon Energy Com-
3 mission.

4 (2) Subsection (1) of this section does not affect, alter, transfer or limit the authority
5 granted to the Energy Facility Siting Council under ORS 469.300 to 469.563, 469.590 to 469.619,
6 469.930 and 469.992, or the authority of the director granted under ORS 469.040 (1)(a) in
7 supervising and facilitating the work and research on energy facility siting applications at
8 the direction of the council.

9
10 (Action, Proceeding, Prosecution)

11
12 SECTION 7. The transfer of duties, functions and powers to the Oregon Energy Com-
13 mission by section 6 of this 2017 Act does not affect any action, proceeding or prosecution
14 involving or with respect to the duties, functions and powers begun before and pending at
15 the time of the transfer, except that the Oregon Energy Commission is substituted for the
16 State Department of Energy or the Director of the State Department of Energy in the
17 action, proceeding or prosecution.

18
19 (Liability, Duty, Obligation)

20
21 SECTION 8. (1) Nothing in sections 2 to 10 or 14 to 17 of this 2017 Act, the amendments
22 to statutes and session law by sections 1, 11, 12 and 18 to 105 of this 2017 Act or the repeal
23 of statutes by section 13 of this 2017 Act relieves a person of a liability, duty or obligation
24 accruing under or with respect to the duties, functions and powers transferred by section 6
25 of this 2017 Act. The Oregon Energy Commission may undertake the collection or enforce-
26 ment of any such liability, duty or obligation.

27 (2) The rights and obligations of the State Department of Energy legally incurred under
28 contracts, leases and business transactions executed, entered into or begun before the op-
29 erative date of section 6 of this 2017 Act accruing under or with respect to the duties, func-
30 tions and powers transferred by section 6 of this 2017 Act are transferred to the Oregon
31 Energy Commission. For the purpose of succession to these rights and obligations, the
32 Oregon Energy Commission is a continuation of the State Department of Energy and the
33 Director of the State Department of Energy and not a new authority.

35 (Rules)

36
37 SECTION 9. Notwithstanding the transfer of duties, functions and powers by section 6
38 of this 2017 Act, the rules of the State Department of Energy and the Director of the State
39 Department of Energy with respect to such duties, functions or powers that are in effect on
40 the operative date of section 6 of this 2017 Act continue in effect until superseded or repealed
41 by rules of the Oregon Energy Commission. References in the rules of the State Department
42 of Energy to the State Department of Energy or an officer or employee of the State De-
43 partment of Energy with respect to the duties, functions and powers transferred by section
44 6 of this 2017 Act are considered to be references to the Oregon Energy Commission.

45 SECTION 10. Whenever, in any statutory or uncodified law or resolution of the Legisla-

1 **tive Assembly or in any rule, document, record or proceeding authorized by the Legislative**
 2 **Assembly, in the context of the duties, functions and powers transferred by section 6 of this**
 3 **2017 Act, reference is made to the State Department of Energy, the Director of the State**
 4 **Department of Energy or an officer or employee of the State Department of Energy whose**
 5 **duties, functions or powers are transferred by section 6 of this 2017 Act, the reference is**
 6 **considered to be a reference to the Oregon Energy Commission or an officer or employee of**
 7 **the Oregon Energy Commission who by this 2017 Act is charged with carrying out the duties,**
 8 **functions and powers.**

 10 **STATE DEPARTMENT OF ENERGY ADMINISTRATION**

11
 12 **(Modification of General Duties)**

13
 14 **SECTION 11.** ORS 469.030 is amended to read:

15 469.030. *[(1) There is created the State Department of Energy.]*

16 **(1) There is created under the Oregon Energy Commission a department to be known as**
 17 **the State Department of Energy. The department shall consist of the Director of the State**
 18 **Department of Energy and all personnel employed in the department. The primary purpose**
 19 **of the department shall be to provide expert advice to the Governor and the Legislative As-**
 20 **sembly on energy-related matters.**

21 **(2) Subject to the policy direction of the Oregon Energy Commission, and in furtherance**
 22 **of the purpose stated in subsection (1) of this section, the State Department of Energy shall:**

23 **(a) [Be] Collect, compile and analyze energy data and serve as the central repository within**
 24 **the state government for [the collection of data on energy resources;] energy information, to which**
 25 **all agencies shall send information on all energy-related research;**

26 **(b) Monitor energy industry research and developments;**

27 *[(b) Endeavor to utilize all public and private sources to inform and educate the public about en-*
 28 *ergy problems and ways in which the public can conserve energy resources;]*

29 **(c) Engage in research, but whenever possible, contract with appropriate public or private**
 30 **agencies and dispense funds for research projects and other services related to energy resources,**
 31 **except that the State Department of Energy shall endeavor to avoid duplication of research whether**
 32 **completed or in progress;**

33 **(d) Qualify for, accept and disburse or utilize any private or federal moneys or services available**
 34 **for the administration of ORS [176.820,] 192.501 to 192.505, [192.690,] 469.010 to 469.155, 469.300 to**
 35 **469.563, 469.990, 757.710 and 757.720;**

36 **(e) Administer federal and state energy allocation and conservation programs and energy re-**
 37 **search and development programs and apply for and receive available funds [therefor] for the pro-**
 38 **grams;**

39 *[(f) Be a clearinghouse for energy research to which all agencies shall send information on all*
 40 *energy related research;]*

41 *[(g) (f) Prepare contingent energy programs to include all forms of energy not otherwise pro-*
 42 *vided pursuant to ORS 757.710 and 757.720;*

43 *[(h) Maintain an inventory of energy research projects in Oregon and the results thereof;]*

44 *[(i) Collect, compile and analyze energy statistics, data and information;]*

45 *[(j) (g) Contract with public and private agencies for energy activities consistent with ORS*

1 469.010 and this section;

2 [(k)] (h) Upon request of the governing body of any affected jurisdiction, coordinate a public
3 review of a proposed transmission line according to the provisions of ORS 469.442; and

4 [(L) Advise the Governor on energy-related matters.]

5 (i) **Provide staff support to the Oregon Hanford Cleanup Board, the Energy Facility Siting
6 Council and the Oregon Global Warming Commission.**

7
8 (Director)

9
10 **SECTION 12.** ORS 469.040 is amended to read:

11 469.040. (1) The State Department of Energy shall be under the supervision of the Director of
12 the State Department of Energy, who shall:

13 [(a) Supervise the day-to-day functions of the State Department of Energy;]

14 [(b)] (a) Supervise and facilitate the work and research on energy facility siting applications at
15 the direction of the Energy Facility Siting Council; **and**

16 (b) **Subject to the direction of the Oregon Energy Commission:**

17 (A) **Supervise the day-to-day functions of the State Department of Energy; and**

18 [(c)] (B) Hire, assign, reassign and coordinate personnel of the State Department of Energy,
19 prescribe their duties and fix their compensation, subject to the State Personnel Relations Law[;
20 and].

21 [(d) Adopt rules and issue orders to carry out the duties of the director and the State Department
22 of Energy in accordance with ORS chapter 183 and the policy stated in ORS 469.010.]

23 (2) The director may delegate to any officer or employee the exercise and discharge in the
24 director's name of any power, duty or function of whatever character vested in the director by law.
25 The official act of any person acting in the director's name and by the director's authority shall be
26 considered an official act of the director.

27 (3) The director shall be appointed by the [Governor] **Oregon Energy Commission, subject to
28 confirmation by the Senate in the manner provided by ORS 171.562 and 171.565.**

29
30 (Statewide Strategic Energy Plan)

31
32 **SECTION 13.** ORS 469.060 and 469.070 are repealed.

33 **SECTION 14.** Sections 15 and 17 of this 2017 Act are added to and made a part of ORS
34 469.010 to 469.155.

35 **SECTION 15.** (1) The State Department of Energy shall develop a statewide strategic
36 energy plan to implement the energy policies stated in ORS 469.010 and 469.310 in a manner
37 that:

38 (a) **Takes a balanced approach to addressing the competing interests affected by the
39 policies stated in ORS 469.010 and 469.310; and**

40 (b) **Provides for transparency and accountability in the actions of the department and the
41 Oregon Energy Commission.**

42 (2) **The statewide strategic energy plan shall include:**

43 (a) **A description of this state's long-term energy needs;**

44 (b) **The objectives of the plan;**

45 (c) **Actions that are designed to achieve the objectives of the plan;**

1 (d) Plans related to the challenges presented by climate change;

2 (e) Provisions to ensure communication and partnership with key stakeholders;

3 (f) Quantitative and qualitative metrics for assessing the performance of the commission
4 and the department in implementing the plan, which shall include, but need not be limited
5 to, metrics related to:

6 (A) The consumption, generation, transmission and production of energy, including fuel
7 energy;

8 (B) Energy costs;

9 (C) Energy sectors, markets, technologies, resources and facilities;

10 (D) Energy efficiency and conservation; and

11 (E) The effects of energy use, including effects related to greenhouse gas emissions;

12 (g) Specific functions and roles to be performed by other state agencies in coordinating
13 with the department to ensure a unified, statewide approach to addressing the energy needs
14 and goals of this state consistent with state environmental policy and the policies set forth
15 in ORS 469.010 and 469.310; and

16 (h) Public policy options and recommendations.

17 (3) The statewide strategic energy plan shall take effect upon adoption by the commis-
18 sion.

19 (4) The commission shall periodically review and update the statewide strategic energy
20 plan. The review required by this section shall include an analysis of how each of the pro-
21 grams of the department contributes to meeting the goals of the statewide strategic energy
22 plan and how each program can most effectively be administered in furtherance of the plan.
23 Revisions of the plan shall take effect upon the commission's adoption of the revised plan
24 by reference in rule.

25 **SECTION 16.** (1) The Oregon Energy Commission shall initially adopt the statewide
26 strategic energy plan required by section 15 of this 2017 Act no later than January 1, 2020.

27 (2) The State Department of Energy shall prepare a draft statewide strategic energy plan
28 and a report, that may include recommendations for legislation, on the draft plan. The de-
29 partment shall, no later than September 15, 2019, submit the draft plan and the report to the
30 appropriate interim committees of the Legislative Assembly in the manner provided under
31 ORS 192.245.

32 **SECTION 17.** (1) No later than November 1 of every even-numbered year, the State De-
33 partment of Energy shall transmit to the Governor and the Legislative Assembly a compre-
34 hensive report on energy resources, policies, trends and forecasts in Oregon. The purposes
35 of the report shall be to inform local, state, regional and federal energy policy development,
36 energy planning and energy investments and to identify opportunities to further the energy
37 policies stated in ORS 469.010 and 469.310 in conformance with the statewide strategic energy
38 plan required under section 15 of this 2017 Act.

39 (2) Consistent with the legislatively approved budget, the report shall include, but need
40 not be limited to:

41 (a) Information on and analysis of the state's progress toward achieving the goals of the
42 statewide strategic energy plan required by section 15 of this 2017 Act and on the effective-
43 ness of the department's programs in contributing to meeting the goals of the plan.

44 (b) Information on the impact of activities carried out by the Oregon Energy Commission
45 and the department on achieving the greenhouse gas emissions reduction goals set forth in

1 **ORS 468A.205.**

2 (c) **Data and information on:**

3 (A) **The consumption, generation, transmission and production of energy, including fuel**
4 **energy;**

5 (B) **Energy costs;**

6 (C) **Energy sectors, markets, technologies, resources and facilities;**

7 (D) **Energy efficiency and conservation;**

8 (E) **The effects of energy use, including effects related to greenhouse gas emissions;**

9 (F) **Local, state, regional and federal regulations, policies and planning activities related**
10 **to energy; and**

11 (G) **Emerging energy opportunities, challenges and impacts.**

12 (3) **The report may include, but need not be limited to:**

13 (a) **Recommendations for the development and maximum use of cost-effective conserva-**
14 **tion methods and renewable resources, consistent with the statewide strategic energy plan,**
15 **the energy policies stated in ORS 469.010 and 469.310 and, where appropriate, the energy plan**
16 **and fish and wildlife program adopted by the Pacific Northwest Electric Power and Conser-**
17 **vation Planning Council pursuant to P.L. 96-501; and**

18 (b) **Recommendations for proposed research, development and demonstration projects**
19 **and programs necessary to further the purposes of the statewide strategic energy plan and**
20 **energy policies stated in ORS 469.010 and 469.310.**

21 (4) **The report shall be compiled by collecting, organizing and refining data and informa-**
22 **tion:**

23 (a) **Acquired by the department in the performance of the department's existing duties;**
24 **or**

25 (b) **Required by the commission by rule to be submitted to the department for purposes**
26 **of compiling the report.**

27 (5) **Upon request from the department, other agencies shall assist the department in the**
28 **performance of the department's duties under this section.**

29 (6) **The department shall seek public input and provide opportunities for public comment**
30 **during the development of the report.**

31
32 **(Other State Department of Energy Administrative Provisions)**

33
34 **SECTION 18.** ORS 469.085 is amended to read:

35 469.085. (1) Except as otherwise provided in this section, civil penalties under ORS 469.992 shall
36 be imposed as provided in ORS 183.745.

37 (2) Notwithstanding ORS 183.745 (2), the notice to the person against whom a civil penalty is
38 to be imposed shall reflect a complete statement of the consideration given to the factors listed in
39 subsection (7) of this section. The notice may be served by either the [*Director of the State Depart-*
40 *ment of Energy*] **Oregon Energy Commission** or the Energy Facility Siting Council.

41 (3) Notwithstanding ORS 183.745, if a hearing is not requested or if the person requesting a
42 hearing fails to appear, a final order shall be entered upon a prima facie case made on the record
43 of the agency.

44 (4) The provisions of this section are in addition to and not in lieu of any other penalty or
45 sanction provided by law. An action taken by the [*director*] **commission** or the council under this

1 section may be joined by the [*director*] **commission** or the council with any other action against the
2 same person under this chapter.

3 (5) Any civil penalty recovered under this section shall be paid into the General Fund.

4 (6) The [*director*] **commission** or the council shall adopt by rule a schedule of the amount of
5 civil penalty that may be imposed for a particular violation.

6 (7) In imposing a penalty under ORS 469.992, the [*director*] **commission** or the council shall
7 consider:

8 (a) The past history of the person incurring a penalty in taking all feasible steps or procedures
9 necessary or appropriate to correct or prevent any violation;

10 (b) Any prior violations of ORS chapter 469 or rules, orders or permits relating to the alleged
11 violation;

12 (c) The impact of the violation on public health and safety or public interests in fishery, navi-
13 gation and recreation;

14 (d) Any other factors determined by the [*director*] **commission** or the council to be relevant;
15 and

16 (e) The alleged violator's cooperativeness and effort to correct the violation.

17 (8) The penalty imposed under ORS 469.992 may be remitted or mitigated upon such terms and
18 conditions as the [*director*] **commission** or council determines to be proper. Upon the request of the
19 person incurring the penalty, the [*director*] **commission** or council shall consider evidence of the
20 economic and financial condition of the person in determining whether a penalty shall be remitted
21 or mitigated.

22 **SECTION 19.** ORS 469.110 is amended to read:

23 469.110. (1) At the direction of the [*Director of the State Department of Energy*] **Oregon Energy**
24 **Commission**, the State Department of Energy may represent the state's energy-related interests in
25 any matter involving the federal government, its departments or agencies, which is within the scope
26 of the power and duties of the State Department of Energy, and may, upon request, represent the
27 interest of a county, city, state agency, federally recognized Native American or American Indian
28 tribe, special district or owner or operator of an energy facility.

29 (2) At the direction of the [*director*] **commission**, the department may intervene in any pro-
30 ceeding undertaken by an agency for the purpose of expressing its views as to the effect of an
31 agency action, upon state energy resources and state energy policy.

32 **SECTION 20.** ORS 469.120 is amended to read:

33 469.120. (1) The State Department of Energy Account is established.

34 (2) The account shall consist of all funds received by the State Department of Energy pursuant
35 to law. All moneys in the account are continuously appropriated to the State Department of Energy
36 for payment of expenses of the department, **the Oregon Energy Commission** and [*of*] the Energy
37 Facility Siting Council.

38 (3) Moneys collected under ORS 469.421 (8) may be expended only for the purposes of programs
39 and activities that the **commission, the** council and the department are charged with administering
40 and authorized to conduct under the laws of this state, including those enumerated in ORS 469.030.

41 (4) The Director of the State Department of Energy shall keep a record of all moneys deposited
42 in the account. The record shall indicate by special cumulative accounts the source from which
43 moneys are derived and the individual activity or program, including any activities described in ORS
44 469.424, against which each withdrawal is charged. On or after October 1 of each year, the director
45 shall make available, upon request, the record for the prior fiscal year to any energy resource sup-

1 plier that has paid the assessment imposed under ORS 469.421 (8). The director shall make the re-
 2 cord available within 30 days of receiving the request.

27 (b) Criteria to be established under this subsection must address:

- 28 (A) The impact of emissions, including but not limited to nitrous oxide, sulfur oxide, carbon
 29 monoxide, carbon dioxide and particulates, from various equipment options, on the environment, re-
 30 gardless of whether the equipment is installed indoors or installed outdoors;
 31 (B) Life cycle costs, including but not limited to acquisition costs, installation and commission-
 32 ing costs, siting and permitting costs, maintenance costs and fueling and decommissioning costs; and
 33 (C) The complexity of equipment options and any ancillary equipment.

5 (3) The [*State Department of Energy*] **Oregon Energy Commission**, in consultation with au-
6 thorized state agencies, shall adopt rules to carry out the provisions of ORS 276.900 to 276.915.

8 (a) Include a simplified and usable method for determining which energy conservation measures

41 is derived from:

42 (A) Forest or rangeland woody debris from harvesting or thinning conducted to improve forest
43 or rangeland ecological health and reduce uncharacteristic stand replacing wildfire risk;

44 (B) Wood material from hardwood timber described in ORS 321.267 (3);

45 (C) Agricultural residues;

- 1 (D) Offal and tallow from animal rendering;
- 2 (E) Food wastes collected as provided under ORS chapter 459 or 459A;
- 3 (F) Wood debris collected as provided under ORS chapter 459 or 459A;
- 4 (G) Wastewater solids; or
- 5 (H) Crops grown solely to be used for energy.
- 6 (e) “Biomass” does not mean wood that has been treated with creosote, pentachlorophenol, in-
- 7 organic arsenic or other inorganic chemical compounds or waste, other than matter described in
- 8 paragraph (d) of this subsection.
- 9 (f) “Biomass collector” means a person that collects biomass in Oregon to be used, in Oregon,
- 10 as biofuel or to produce biofuel.
- 11 (g) “Canola” means plants of the genus Brassica:
- 12 (A) In which seeds having a high oil content are the primary economically valuable product; and
- 13 (B) That have a high erucic acid content suitable for industrial uses or a low erucic acid content
- 14 suitable for edible oils.
- 15 (h) “Oilseed processor” means a person that receives agricultural oilseeds and separates them
- 16 into meal and oil by mechanical or chemical means.
- 17 (i) “Willamette Valley” means Clackamas, Linn, Marion, Multnomah, Polk, Washington and
- 18 Yamhill Counties and the portion of Benton and Lane Counties lying east of the summit of the Coast
- 19 Range.
- 20 (2) The [*Director of the State Department of Energy*] **Oregon Energy Commission** may adopt
- 21 rules to define criteria, only as the criteria apply to organic biomass, to determine additional char-
- 22 acteristics of biomass for purposes of this section.
- 23 (3)(a) An agricultural producer or biomass collector shall be allowed a credit against the taxes
- 24 that would otherwise be due under ORS chapter 316 or, if the taxpayer is a corporation, under ORS
- 25 chapter 317 or 318 for:
- 26 (A) The production of biomass in Oregon that is used, in Oregon, as biofuel or to produce
- 27 biofuel; or

 - (A) A statement of the reasonably expected energy savings of the device;
 - (B) A copy of consumer information published by the State Department of Energy;
 - (C) An operating manual for the alternative energy device; and
 - (D) A copy of the contractor's certification certificate or alternative energy device system cer-

1 tificate for the alternative energy device, as appropriate;

2 (e) If the device was not constructed or installed by a contractor, evidence that:

3 (A) The State Department of Energy has issued an alternative energy device system certificate
4 for the alternative energy device; and

5 (B) The taxpayer has obtained all building permits required for construction or installation of
6 the device;

7 (f) A statement, signed by both the taxpayer claiming the credit and the contractor if the device
8 was constructed or installed by a contractor, that the construction or installation meets all the re-
9 quirements of ORS 469B.100 to 469B.118;

13 five years, unless the [*director*] **Oregon Energy Commission** by rule specifies another period of
14 operation;

15 (f) Documentation of compliance with applicable state and local laws and regulations and li-
16 censing and permitting requirements as defined by the [*director*] **Oregon Energy Commission**; and

17 (g) Any other information determined by the director to be necessary prior to issuance of a final
18 certificate, including inspection of the project by the department.

19 (4) After the filing of the application under this section, the director may issue the certificate
20 together with any conditions that the director determines are appropriate to promote the purposes
21 of ORS 315.336 and 469B.320 to 469B.347. If the applicant is an entity subject to regulation by the
22 Public Utility Commission, the director may consult with the **Public Utility** Commission prior to
23 issuance of the certificate. The action of the director shall include certification of the actual cost

- 8 (14) “Jobs, Energy and Schools Fund” means the fund established under ORS 470.575.
- 9 (15) “Loan” includes the purchase or other acquisition of evidence of indebtedness and money
10 used for the purchase or other acquisition of evidence of indebtedness.
- 11 (16) “Loan contract” means the evidence of indebtedness and all instruments used in the pur-
12 chase or acquisition of the evidence of indebtedness. For eligible federal or state agencies or mu-
13 nicipal corporations that are tax exempt entities, a loan contract may include a lease purchase

28 **Commission** shall adopt rules as necessary to implement ORS 757.522 to 757.536.

29 **SECTION 103.** ORS 757.600 is amended to read:

30 757.600. As used in ORS 757.600 to 757.689, unless the context requires otherwise:

31 (1) "Aggregate" means combining retail electricity consumers into a buying group for the pur-
32 chase of electricity and related services.

33 (2) "Ancillary services" means services necessary or incidental to the transmission and delivery
34 of electricity from generating facilities to retail electricity consumers, including but not limited to
35 scheduling, load shaping, reactive power, voltage control and energy balancing services.

36 (3) "Commission" means the Public Utility Commission.

37 (4) "Consumer-owned utility" means a municipal electric utility, a people's utility district or an
38 electric cooperative.

39 (5) "Default supplier" means an electricity service supplier or electric company that has a legal
40 obligation to provide electricity services to a consumer, as determined by the commission.

41 (6) "Direct access" means the ability of a retail electricity consumer to purchase electricity and
42 certain ancillary services, as determined by the commission for an electric company or the govern-
43 ing body of a consumer-owned utility, directly from an entity other than the distribution utility.

44 (7) "Direct service industrial consumer" means an end user of electricity that obtains electricity
45 directly from the transmission grid and not through a distribution utility.

1 (8) "Distribution" means the delivery of electricity to retail electricity consumers through a
2 distribution system consisting of local area power poles, transformers, conductors, meters, sub-
3 stations and other equipment.

4 (9) "Distribution utility" means an electric utility that owns and operates a distribution system
5 connecting the transmission grid to the retail electricity consumer.

6 (10) "Economic utility investment" means all electric company investments, including plants and
7 equipment and contractual or other legal obligations, properly dedicated to generation or conser-
8 vation, that were prudent at the time the obligations were assumed but the full benefits of which
9 are no longer available to consumers as a direct result of ORS 757.600 to 757.667, absent transition
10 credits. "Economic utility investment" does not include costs or expenses disallowed by the com-
11 mission in a prudence review or other proceeding, to the extent of such disallowance, and does not
12 include fines or penalties authorized and imposed under state or federal law.

13 (11) "Electric company" means an entity engaged in the business of distributing electricity to
14 retail electricity consumers in this state, but does not include a consumer-owned utility.

15 (12) "Electric cooperative" means an electric cooperative corporation organized under ORS
16 chapter 62 or under the laws of another state if the service territory of the electric cooperative
17 includes a portion of this state.

18 (13) "Electric utility" means an electric company or consumer-owned utility that is engaged in
19 the business of distributing electricity to retail electricity consumers in this state.

20 (14) "Electricity" means electric energy, measured in kilowatt-hours, or electric capacity,
21 measured in kilowatts, or both.

22 (15) "Electricity services" means electricity distribution, transmission, generation or
23 generation-related services.

24 (16) "Electricity service supplier" means a person or entity that offers to sell electricity services
25 available pursuant to direct access to more than one retail electricity consumer. "Electricity ser-
26 vice supplier" does not include an electric utility selling electricity to retail electricity consumers
27 in its own service territory.

28 (17) "Governing body" means the board of directors or the commissioners of an electric coop-
29 erative or people's utility district, or the council or board of a city with respect to a municipal
30 electric utility.

31 (18) "Load" means the amount of electricity delivered to or required by a retail electricity

33 (19) "Low-income weatherization" means repairs, weatherization and installation of energy effi-

36 (20) "Municipal electric utility" means an electric distribution utility owned and operated by or
37 on behalf of a city.

38 (21) "New renewable energy resource" means a renewable energy resource project, or a new
39 addition to an existing renewable energy resource project, or the electricity produced by the project,
40 that is not in operation on July 23, 1999. "New renewable energy resource" does not include any
41 portion of a renewable energy resource project under contract to the Bonneville Power Adminis-
42 tration on or before July 23, 1999.

43 (22) "One average megawatt" means 8,760,000 kilowatt-hours of electricity per year.

44 (23) "People's utility district" has the meaning given that term in ORS 261.010.

45 (24) "Portfolio access" means the ability of a retail electricity consumer to choose from a set

1 of product and pricing options for electricity determined by the governing board of a consumer-
2 owned utility and may include product and pricing options offered by the utility or by an electricity
3 service supplier.

4 (25) "Power generation company" means a company engaged in the production and sale of
5 electricity to wholesale customers, including but not limited to independent power producers, affil-
6 iated generation companies, municipal and state authorities, provided the company is not regulated
7 by the commission.

8 (26) "Qualifying expenditures" means those expenditures for energy conservation measures that
9 have a simple payback period of not less than one year and not more than 10 years, and expen-
10 ditures for the above-market costs of new renewable energy resources, provided that the [*State De-*
11 *partment of Energy*] **Oregon Energy Commission** by rule may establish a limit on the maximum
12 above-market cost for renewable energy that is allowed as a credit.

13 (27) "Renewable energy resources" means:

14 (a) Electricity generation facilities fueled by wind, waste, solar or geothermal power or by low-
15 emission nontoxic biomass based on solid organic fuels from wood, forest and field residues.

16 (b) Dedicated energy crops available on a renewable basis.

17 (c) Landfill gas and digester gas.

18 (d) Hydroelectric facilities located outside protected areas as defined by federal law in effect
19 on July 23, 1999.

20 (28) "Residential electricity consumer" means an electricity consumer who resides at a dwelling
21 primarily used for residential purposes. "Residential electricity consumer" does not include retail
22 electricity consumers in a dwelling typically used for residency periods of less than 30 days, in-
23 cluding hotels, motels, camps, lodges and clubs. As used in this subsection, "dwelling" includes but
24 is not limited to single family dwellings, separately metered apartments, adult foster homes, manu-
25 factured dwellings, recreational vehicles and floating homes.

26 (29) "Retail electricity consumer" means the end user of electricity for specific purposes such
27 as heating, lighting or operating equipment, and includes all end users of electricity served through

38 (33) "Transmission facility" means the plant and equipment used to transmit electricity in
39 interstate commerce.

40 (34) "Undue market power" means the unfair or improper exercise of influence to increase or
41 decrease the availability or price of a service or product in a manner inconsistent with competitive
42 markets.

43 (35) "Uneconomic utility investment" means all electric company investments, including plants
44 and equipment and contractual or other legal obligations, properly dedicated to generation, conser-
45 vation and workforce commitments, that were prudent at the time the obligations were assumed but

1 the full costs of which are no longer recoverable as a direct result of ORS 757.600 to 757.667, absent
2 transition charges. "Uneconomic utility investment" does not include costs or expenses disallowed
3 by the commission in a prudence review or other proceeding, to the extent of such disallowance, and
4 does not include fines or penalties as authorized by state or federal law.

5 **SECTION 104.** ORS 757.612 is amended to read:

6 757.612. (1) There is established an annual public purpose expenditure standard for electric
7 companies and Oregon Community Power to fund new cost-effective local energy conservation, new
8 market transformation efforts, the above-market costs of new renewable energy resources and new
9 low-income weatherization. The public purpose expenditure standard shall be funded by the public
10 purpose charge described in subsection (2) of this section.

11 (2)(a) Beginning on the date an electric company or Oregon Community Power offers direct ac-
12 cess to its retail electricity consumers, except residential electricity consumers, the electric com-
13 pany or Oregon Community Power shall collect a public purpose charge from all of the retail
14 electricity consumers located within its service area until January 1, 2026. Except as provided in
15 paragraph (b) of this subsection, the public purpose charge shall be equal to three percent of the
16 total revenues collected by the electric company, Oregon Community Power or the electricity ser-
17 vice supplier from its retail electricity consumers for electricity services, distribution, ancillary
18 services, metering and billing, transition charges and other types of costs included in electric rates
19 on July 23, 1999.

20 (b) For an aluminum plant that averages more than 100 average megawatts of electricity use
21 per year, beginning on March 1, 2002, the electric company or Oregon Community Power whose
22 territory abuts the greatest percentage of the site of the aluminum plant shall collect from the alu-
23 minum company a public purpose charge equal to one percent of the total revenue from the sale of
24 electricity services to the aluminum plant from any source.

25 (3)(a) The Public Utility Commission shall establish rules implementing the provisions of this
26 section relating to electric companies and Oregon Community Power.

27 (b) Subject to paragraph (e) of this subsection, funds collected by an electric company or Oregon
28 Community Power through public purpose charges shall be allocated as follows:

29 (A) Sixty-three percent for new cost-effective conservation, new market transformation.

30 (B) Nineteen percent for the above-market costs of constructing and operating new renewable

38 Oregon Community Power shall be paid out of the funds collected through public purpose charges.
39 The commission may require that an electric company or Oregon Community Power direct funds
40 collected through public purpose charges to the state agencies responsible for implementing sub-
41 subsections (1) to (6) of this section in order to pay the costs of administering such responsibilities.

42 (d) The commission shall direct the manner in which public purpose charges are collected and
43 spent by an electric company or Oregon Community Power and may require an electric company
44 or Oregon Community Power to expend funds through competitive bids or other means designed to
45 encourage competition, except that funds dedicated for low-income weatherization shall be directed

1 to the Housing and Community Services Department as provided in subsection (7) of this section.
2 The commission may also direct that funds collected by an electric company or Oregon Community
3 Power through public purpose charges be paid to a nongovernmental entity for investment in public

6 (A) At least 80 percent of the funds allocated for conservation shall be spent within the service
7 area of the electric company that collected the funds; or

9 for conservation shall be spent within the service area of Oregon Community Power.

10 (e)(A) The first 10 percent of the funds collected annually by an electric company or Oregon
11 Community Power under subsection (2) of this section shall be distributed to school districts that
12 are located in the service territory of the electric company or Oregon Community Power. The funds
13 shall be distributed to individual school districts according to the weighted average daily member-
14 ship (ADMw) of each school district for the prior fiscal year as calculated under ORS 327.013. The
15 commission shall establish by rule a methodology for distributing a proportionate share of funds
16 under this paragraph to school districts that are only partially located in the service territory of the
17 electric company or Oregon Community Power.

18 (B) A school district that receives funds under this paragraph shall use the funds first to pay
19 for energy audits for schools located within the school district. A school district may not expend
20 additional funds received under this paragraph on a school facility until an energy audit has been

22 the State Department of Energy and incorporate federal funding in complying with this paragraph.
23 Following completion of an energy audit for an individual school, the school district may expend
24 funds received under this paragraph to implement the energy audit. Once an energy audit has been
25 conducted and completely implemented for each school within the school district, the school district
26 may expend funds received under this paragraph for any of the following purposes:

27 (i) Conducting energy audits. A school district shall conduct an energy audit prior to expending
28 funds on any other purpose authorized under this paragraph unless the school district has performed
29 an energy audit within the three years immediately prior to receiving the funds.

30 (ii) Weatherization and upgrading the energy efficiency of school district facilities.

31 (iii) Energy conservation education programs.

32 (iv) Purchasing electricity from environmentally focused sources and investing in renewable

34 (f) The commission may not establish a different public purpose charge than the public purpose
35 charge described in subsection (2) of this section.

36 (g) If the commission directs funds collected through public purpose charges to a nongovern-
37 mental entity, the entity shall:

38 (A) Include on the entity's board of directors an ex officio member designated by the commis-
39 sion, who shall also serve on the entity's nominating committee for filling board vacancies.

40 (B) Require the entity's officers and directors to provide an annual disclosure of economic in-
41 terest to be filed with the commission on or prior to April 15 of each calendar year for public review
42 in a form similar to the statement of economic interest required for public officials under ORS
43 244.060.

44 (C) Require the entity's officers and directors to declare actual and potential conflicts of interest
45 at regular meetings of the entity's governing body when such conflicts arise, and require an officer

1 or director to abstain from participating in any discussion or vote on any item where that officer
2 or director has an actual conflict of interest. For the purposes of this subparagraph, “actual conflict
3 of interest” and “potential conflict of interest” have the meanings given those terms in ORS 244.020.

4 (D) Arrange for an independent auditor to audit the entity’s financial statements annually, and
5 direct the auditor to file an audit opinion with the commission for public review.

6 (E) File with the commission annually the entity’s budget, action plan and quarterly and annual
7 reports for public review.

8 (F) At least once every five years, contract for an independent management evaluation to review
9 the entity’s operations, efficiency and effectiveness, and direct the independent reviewer to file a
10 report with the commission for public review.

11 (h) The commission may remove from the board of directors of a nongovernmental entity an of-
12 ficer or director who fails to provide an annual disclosure of economic interest or declare actual
13 or potential conflict of interest, as described in paragraph (g)(B) and (C) of this subsection, in con-
14 nection with the allocation or expenditure of funds collected through public purpose charges and
15 directed to the entity.

16 (4)(a) An electric company that satisfies its obligations under this section shall have no further
17 obligation to invest in conservation, new market transformation or new low-income weatherization
18 or to provide a commercial energy conservation services program and is not subject to ORS 469.631
19 to 469.645 and 469.860 to 469.900.

20 (b) Oregon Community Power, for any period during which Oregon Community Power collects
21 a public purpose charge under subsection (2) of this section:

22 (A) Shall have no other obligation to invest in conservation, new market transformation or new
23 low-income weatherization or to provide a commercial energy conservation services program; and

24 (B) Is not subject to ORS 469.631 to 469.645 and 469.860 to 469.900.

25 (5)(a) A retail electricity consumer that uses more than one average megawatt of electricity at
26 any site in the prior year shall receive a credit against public purpose charges billed by an electric
27 company or Oregon Community Power for that site. The amount of the credit shall be equal to the
28 total amount of qualifying expenditures for new energy conservation, not to exceed 68 percent of the
29 annual public purpose charges, and the above-market costs of purchases of new renewable energy
30 resources incurred by the retail electricity consumer, not to exceed 19 percent of the annual public
31 purpose charges, less administration costs incurred under this subsection. The credit may not ex-
32 ceed, on an annual basis, the lesser of:

33 (A) The amount of the retail electricity consumer’s qualifying expenditures; or

34 (B) The portion of the public purpose charge billed to the retail electricity consumer that is
35 dedicated to new energy conservation, new market transformation or the above-market costs of new
36 renewable energy resources.

37 (b) To obtain a credit under this subsection, a retail electricity consumer shall file with the
38 State Department of Energy a description of the proposed conservation project or new renewable
39 energy resource and a declaration that the retail electricity consumer plans to incur the qualifying
40 expenditure. The State Department of Energy shall issue a notice of precertification within 30 days
41 of receipt of the filing, if such filing is consistent with this subsection. The credit may be taken after
42 a retail electricity consumer provides a letter from a certified public accountant to the State De-
43 partment of Energy verifying that the precertified qualifying expenditure has been made.

44 (c) Credits earned by a retail electricity consumer as a result of qualifying expenditures that
45 are not used in one year may be carried forward for use in subsequent years.

1 (d)(A) A retail electricity consumer that uses more than one average megawatt of electricity at
2 any site in the prior year may request that the State Department of Energy hire an independent
3 auditor to assess the potential for conservation investments at the site. If the independent auditor
4 determines there is no available conservation measure at the site that would have a simple payback
5 of one to 10 years, the retail electricity consumer shall be relieved of 54 percent of its payment
6 obligation for public purpose charges related to the site. If the independent auditor determines that
7 there are potential conservation measures available at the site, the retail electricity consumer shall
8 be entitled to a credit against public purpose charges related to the site equal to 54 percent of the
9 public purpose charges less the estimated cost of available conservation measures.

10 (B) A retail electricity consumer shall be entitled each year to the credit described in this sub-
11 section unless a subsequent independent audit determines that new conservation investment oppor-
12 tunities are available. The State Department of Energy may require that a new independent audit
13 be performed on the site to determine whether new conservation measures are available, provided
14 that the independent audits shall occur no more than once every two years.

15 (C) The retail electricity consumer shall pay the cost of the independent audits described in this
16 subsection.

17 (6) Electric utilities and retail electricity consumers shall receive a fair and reasonable credit
18 for the public purpose expenditures of their energy suppliers. The [*State Department of Energy*]
19 **Oregon Energy Commission** shall adopt rules to determine eligible expenditures and the method-
20 ology by which such credits are accounted for and used. The rules also shall adopt methods to ac-
21 count for eligible public purpose expenditures made through consortia or collaborative projects.

22 (7)(a) In addition to the public purpose charge provided under subsection (2) of this section, an
23 electric company or Oregon Community Power shall collect funds for low-income electric bill pay-
24 ment assistance in an amount determined under paragraph (b) of this subsection.

25 (b) The **Public Utility** Commission shall establish the amount to be collected by each electric
26 company in calendar year 2008 from retail electricity consumers served by the company, and the
27 rates to be charged to retail electricity consumers served by the company, so that the total antic-
28 ipated collection for low-income electric bill payment assistance by all electric companies in calen-
29 dar year 2008 is \$15 million. In calendar year 2009 and subsequent calendar years, the commission
30 may not change the rates established for retail electricity consumers, but the total amount collected
31 in a calendar year for low-income electric bill payment assistance may vary based on electricity
32 usage by retail electricity consumers and changes in the number of retail electricity consumers in
33 this state. In no event shall a retail electricity consumer be required to pay more than \$500 per
34 month per site for low-income electric bill payment assistance.

35 (c) Funds collected by the low-income electric bill payment assistance charge shall be paid into
36 the Housing and Community Services Department Low-Income Electric Bill Payment Assistance
37 Fund established by ORS 456.587 (2). Moneys deposited in the fund under this paragraph shall be
38 used by the Housing and Community Services Department for the purpose of funding low-income
39 electric bill payment assistance. The department's cost of administering this subsection shall be paid
40 out of funds collected by the low-income electric bill payment assistance charge. Moneys deposited
41 in the fund under this paragraph shall be expended solely for low-income electric bill payment as-
42 sistance. Funds collected from an electric company or Oregon Community Power shall be expended
43 in the service area of the electric company or Oregon Community Power from which the funds are
44 collected.

45 (d)(A) The Housing and Community Services Department shall determine the manner in which

1 funds collected under this subsection will be allocated by the department to energy assistance pro-
2 gram providers for the purpose of providing low-income bill payment and crisis assistance.

3 (B) The department shall investigate and may implement alternative delivery models in consul-
4 tation with electric companies to effectively reduce service disconnections and related costs to retail
5 electricity consumers and electric utilities.

6 (C) Priority assistance shall be directed to low-income electricity consumers who are in danger
7 of having their electricity service disconnected.

8 (D) The department shall maintain records and provide those records upon request to an electric
9 company, Oregon Community Power and the Citizens' Utility Board established under ORS chapter
10 774 on a quarterly basis. Records maintained must include the numbers of low-income electricity
11 consumers served, the average amounts paid and the type of assistance provided. Electric companies
12 and Oregon Community Power shall, if requested, provide the department with aggregate data re-
13 lating to consumers served on a quarterly basis to support program development.

14 (e) Interest on moneys deposited in the Housing and Community Services Department Low-
15 Income Electric Bill Payment Assistance Fund established by ORS 456.587 (2) may be used to pro-
16 vide bill payment and crisis assistance to electricity consumers whose primary source of heat is not
17 electricity.

18 (f) Notwithstanding ORS 757.310, the commission may allow an electric company or Oregon
19 Community Power to provide reduced rates or other payment or crisis assistance or low-income
20 program assistance to a low-income household eligible for assistance under the federal Low Income
21 Home Energy Assistance Act of 1981, as amended and in effect on July 23, 1999.

22 (8) For purposes of this section, "retail electricity consumers" includes any direct service in-
23 dustrial consumer that purchases electricity without purchasing distribution services from the elec-
24 tric utility.

25 (9) For purposes of this section, amounts collected by Oregon Community Power through public
26 purpose charges are not considered moneys received from electric utility operations.

27 **SECTION 105.** Section 9, chapter 774, Oregon Laws 2013, is amended to read:

28 **Sec. 9.** (1) A credit against the taxes that are otherwise due under ORS chapter 316 or, if the
29 taxpayer is a corporation, under ORS chapter 317 or 318, is allowed to a taxpayer for certified al-
30 ternative fuel vehicle contributions made by the taxpayer during the tax year to the Alternative
31 Fuel Vehicle Revolving Fund established under [section 2 of this 2013 Act] **ORS 469.961.**

32 (2)(a) The Department of Revenue shall, in cooperation with the State Department of Energy,
33 conduct an auction of tax credits under this section. The Department of Revenue may not auction
34 more than \$3 million of tax credits under this section. The department may conduct the auction in
35 the manner that the department determines is best suited to maximize the return to the state on the
36 sale of tax credit certifications and shall announce a reserve bid prior to conducting the auction.
37 The reserve amount shall be at least 95 percent of the total amount of the tax credit. Moneys nec-
38 cessary to reimburse the Department of Revenue for the actual costs incurred by the department in
39 administering an auction, not to exceed 0.25 percent of auction proceeds, are continuously appro-
40 priated to the department. The Department of Revenue shall deposit net receipts from the auction
41 required under this section in the Alternative Fuel Vehicle Revolving Fund established under [sec-
42 tion 2 of this 2013 Act] **ORS 469.961.** Net receipts from the auction required under this section shall
43 be used to provide loans as described in [section 3 of this 2013 Act] **ORS 469.962.**

44 (b) The [State Department of Energy] **Oregon Energy Commission** shall adopt rules for the
45 administration and implementation of this section.

1 (3) Contributions made under this section shall be deposited in the Alternative Fuel Vehicle
 2 Revolving Fund.

3 (4)(a) Upon receipt of a contribution, the State Department of Energy shall issue to the taxpayer
 4 written certification of the amount certified for tax credit under this section to the extent the
 5 amount certified for tax credit, when added to all amounts previously certified for tax credit under
 6 this section, does not exceed \$3 million for the tax year beginning January 1, 2013.

7 (b) The State Department of Energy and the Department of Revenue are not liable, and a refund
 8 of a contributed amount need not be made, if a taxpayer who has received tax credit certification
 9 is unable to use all or a portion of the tax credit to offset the tax liability of the taxpayer.

10 (5) The tax credit allowed under this section for any one tax year may not exceed the tax li-
 11 ability of the taxpayer.

12 (6) Any tax credit otherwise allowable under this section that is not used by the taxpayer in a
 13 particular tax year may be carried forward and offset against the taxpayer's tax liability for the next
 14 succeeding tax year. Any credit remaining unused in the next succeeding tax year may be carried
 15 forward and used in the second succeeding tax year, and, likewise, any credit not used in the second
 16 succeeding tax year may be carried forward and used in the third succeeding tax year but may not
 17 be carried forward for any tax year thereafter.

18 (7) If a tax credit is claimed under this section by a nonresident or part-year resident taxpayer,
 19 the amount shall be allowed without proration under ORS 316.117.

20 (8) If the amount of contribution for which a tax credit certification is made is allowed as a
 21 deduction for federal tax purposes, the amount of the contribution shall be added to federal taxable
 22 income for Oregon tax purposes.

 26 **SECTION 106. (1) Except as provided in subsection (3) of this section, sections 2 to 10 and**
 27 **14 to 17 of this 2017 Act, the amendments to statutes and session law by sections 1, 11, 12**
 28 **and 18 to 105 of this 2017 Act and the repeal of statutes by section 13 of this 2017 Act become**
 29 **operative July 1, 2018.**

30 (2) **The members of the Oregon Energy Commission may be appointed and the State De-**
 31 **partment of Energy, the Director of the State Department of Energy and the Oregon Energy**
 32 **Commission may take any action before the operative date specified in subsection (1) of this**
 33 **section that is necessary to enable the department, the director and the commission to ex-**
 34 **ercise, on and after the operative date specified in subsection (1) of this section, the duties,**
 35 **functions and powers of the department, the director and the commission pursuant to**
 36 **sections 2 to 10 and 14 to 17 of this 2017 Act, the amendments to statutes and session law**
 37 **by sections 1, 11, 12 and 18 to 105 of this 2017 Act and the repeal of statutes by section 13**
 38 **of this 2017 Act.**

39 (3) **The transfer of duties, functions and powers by section 6 of this 2017 Act does not**
 40 **become operative until the members of the Oregon Energy Commission have been appointed**
 41 **and have qualified. Until appointment and qualification, the State Department of Energy and**
 42 **the Director of the State Department of Energy shall continue to perform the duties and**
 43 **functions and exercise the powers.**
