### **Executive Summary**

The Crescent Sanitary District (CSD) worked with the Portland State University (PSU) Survey Research Lab (SRL) to conduct a community income census of all families living within the CSD proposed service area to determine eligibility for United States Department of Agriculture Rural Development (USDA-RD) and Department of Housing and Urban Development (HUD) grants to fund continued development of the proposed waste water system. From March 10, 2016 to March 17, 2016 and also on April 23, 2016 the SRL sent a trained data collector to Crescent to conduct door-to-door surveys. The SRL was able to complete surveys with 109 of the 135, households in the service area, a household response rate of 80.7%. These households represented 237 of the 293 people who live in the service area or about 80.9% of the total population. Analysis of the data collected found that the median family income for the service area is \$37,000. The results also found that 62 families, representing 132 residents of the CSD, are considered low or moderate income (LMI). This results in 45.1% of the residents of CSD being LMI, which is below the 51% threshold required to apply for Community Development Block Grants (CDBG) to fund infrastructure improvements.

### Methodology

The total number of occupied residences in Crescent Sanitary District was initially estimated to be 215. Due to the small number of households, a census was conducted to determine household income statistics. The goal of 172 completed surveys was set to ensure that an 80% response rate is achieved, as determined by HUD guidelines.

Prior to implementing the data collection, a Community Income Survey notice postcard (Attachment A) was sent to each post office box at the Crescent Post Office to inform the community of the upcoming survey. Additionally, flyers (Attachment B) were posted at the Crescent and Gilchrist Post Offices about the survey. These were posted approximately one week before data collection was set to begin.

PSU's Survey Research Lab (SRL) used a trained data collector to conduct door-to-door data collection. The data collector was trained on standardized data collection techniques to ensure the unbiased collection of demographic surveys. The training included clear information about unbiased data collection techniques, objective interactions with prospective respondents, collecting methodologically valid data, and neutral providing of clarification. The data collector was instructed that there can be no direct or indirect encouragement that might influence respondents to note lower incomes. The data collector signed the Survey Certification Form (Attachment C) agreeing to collect surveys in an appropriate and ethical manner and also signed a Conflict of Interest Form (Attachment D) to ensure compliance with conflict of interest regulations regarding CDBG funding as found at 24 CFR 570.611 so that there is no undue benefit to persons or their affiliates involved in conducting the survey.

Based on the list of all primary residences within the defined service area provided by CSD staff, the survey process used a coded instrument with a random unique ID for each household to ensure the confidentiality of the respondent's data. The data collector used the attached survey questionnaire developed by the PSU SRL (Attachment E) in accordance with guidelines set forth by HUD and USDA-RD.

Data collection began on Friday, 3/11/16, and continued through Thursday, 3/17/16. Limited data collection happened on 3/13/16 through 3/15/16 due to unexpected snowy weather conditions, making data collection hazardous for SRL staff. During the data collection process, SRL staff reviewed

all addresses provided by the CSD and identified 37 nonresidential or undeveloped properties and an additional 43 houses that were currently vacant or occupied by part time residents. This reduced the total number of households in the service area to 135.

Each household was approached by an interviewer who provided the household member with a paper survey (Attachment E) on a clipboard. The prospective respondent was informed of the purpose of the survey using the Door-to-Door Survey Script (Attachment F). The interviewer answered any questions the person had and provided the respondent with a privacy envelope in which s/he could seal their completed survey. This envelope ensured that the survey was protected from view until the surveys were taken to SRL offices and ready for data entry. In instances where more than one family lived in a household, the interviewer used an extra questionnaire for the additional family. The same ID number assigned to that address was used, with the addition of "-2" appended to the end of the ID.

If no one was available at a household, a flyer containing information about the survey (Attachment G) was left on the door, and that household was contacted later using the same door-to-door method. Additional attempts were continued until each household received a maximum of three attempts. Before the data collector left the area, a blank survey form and stamped envelope addressed to the SRL was left at each non-responding household along with the flyer about the survey.

The SRL was able to collect only 83 completed surveys during the initial round of data collection. After consultation with CSD, all properties that were identified by the SRL as vacant were checked by local residents and the SRL data collector returned to Crescent on April 23, 2016. An additional 26 completed surveys were collected, bringing the total to 109 surveys.

All completed surveys were securely transported to the SRL. Data from the completed surveys was then entered into SPSS (Statistical Package for the Social Sciences) and prepared for analysis. Completed paper surveys are kept in a locked file cabinet in a secure location only accessible to SRL staff. All electronic data files are kept on a secure, password-protected server, hosted by PSU.

For the analysis of the data, the median household income (MHI) was determined using the guidelines set forth in Rural Utility Sservices Guide 1708-1 from USDA-RD and the percentage of low and moderate income households (LMI) was determined according to the guidelines set forth in HUD

Notice CPD-14-013<sup>1</sup> (Issued September 23, 2014). The income limits for determing LMI are from the 2015 Method of Distribution published by the Oregon Business Development Department Infrastructure Finance Authority<sup>2</sup> and can also be found in Table 1 below.


### Results

The SRL collected completed surveys from 109 households out of the 135 CSD households, resulting in a household response rate of 80.7%. HUD guidelines for calculating the percentage of the population that is LMI when conducting a census (as outlined in CPD-14-013, page 6, scenario number 3) involves taking the number of people who are found to be LMI from survey results and dividing that by the total population of the service area. Since the CSD is a special district, official population estimates do not exist for the service area; therefore, the CSD population had to be estimated based on the survey findings. The total number of people in households that completed the survey was 237, with an average family size of 2.15. To estimate how many people lived in the additional 26 households that did not participate in the survey, the SRL used the standard procedure of mean substitution. Using this procedure, the average family size of the responding households is applied to those households that did not complete a survey. This method results in an estimated 56 people who did not participate in the survey, for a total population of 293. Using this figure, along with other results from the survey, the percentage of LMI residents in the CSD is 45.1% (Table 2), with a median income of \$37,000 (Table 3).



#### Question 1: How many families currently reside this address?




Nearly all (97.2%, n=106) of households reported only a single family living at the address with, only three households reporting multiple families living at the same address.

#### Question 2: How many people are in your family, including yourself?



Overall, 75.2% (n=82) of households reported a family size of two or less. An additional 20.2% (n=22) of households reported family size of three or four.

Question 3: Which of the following *best* describes your family's total gross income, before taxes, for the previous 12 months?



The most common response to the question about total gross income in the past 12 months was less than \$29,200, with 44.0% (n=48) of households reporting this. The next most common response was \$55,051 or more, which was reported by 25.6% (n=28) of households.
